AN ACT

MAKING AN APPROPRIATION FOR A PILOT HEALTH SERVICES PROGRAM FOR
INDIVIDUALS WITH MULTICHEMICAL SENSITIVITIES OR ENVIRONMENTAL
ILLNESSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Seventy-five thousand dollars
(\$75,000) is appropriated from the general fund to the
department of health for expenditure in fiscal year 1997 for the
purpose of providing or contracting for a pilot program offering
medical services, in any class B county with a population
exceeding ninety thousand people, to individuals with
multichemical sensitivities or environmental illnesses. Any
unexpended or unencumbered balance remaining at the end of
fiscal year 1997 shall revert to the general fund.
