AN ACT

MAKING AN APPROPRIATION TO PROVIDE SERVICES FOR HOMELESS OR
MENTALLY ILL VIETNAM VETERANS; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Two hundred twenty thousand six
hundred fifty dollars (\$220,650) is appropriated from the
general fund to the New Mexico veterans' service commission for
expenditure in fiscal years 1996 and 1997 for the purpose of
providing or contracting for referral, job placement, housing or
supportive social services for homeless or mentally ill Vietnam
veterans. Any unexpended or unencumbered balance remaining at
the end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY. --It is necessary for the public
peace, health and safety that this act take effect immediately.
