AN ACT

MAKING AN APPROPRIATION TO IMPLEMENT TOTAL QUALITY MANAGEMENT
PRINCIPLES IN THE PUBLIC SCHOOL SYSTEM

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Two hundred fifty thousand
dollars (\$250,000) is appropriated from the general fund to the
state department of public education for expenditure in fiscal
year 1997 for the purpose of contracting for the services of a
community-based organization representing business, education
and state government to implement total quality management
principles in selected public schools throughout the state. Any
unexpended or unencumbered balance remaining at the end of
fiscal year 1997 shall revert to the general fund.
