AN ACT

MAKING AN APPROPRIATION TO THE BOARD OF REGENTS OF THE
UNIVERSITY OF NEW MEXICO FOR GRADUATE STUDENT RESEARCH AND
PROJECTS; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Five hundred thousand dollars
(\$500,000) is appropriated from the general fund to the board of
regents of the university of New Mexico for expenditure in
fiscal years 1996 and 1997 for the purpose of providing the
office of graduate studies funding for research, projects and
related expenses for graduate and professional students. Any
unexpended or unencumbered balance remaining at the end of
fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY. -- It is necessary for the public
peace, health and safety that this act take effect immediately.
