AN ACT

MAKING APPROPRIATIONS TO PROVIDE A CONTINUUM OF CARE FOR ADULTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATIONS. --

A. Two million dollars (\$2,000,000) is appropriated from the general fund to the children, youth and families department for expenditure in fiscal year 1997 in the following amounts for the following purposes:

(1) one million dollars (\$1,000,000) to provide or contract for domestic violence prevention programs and services for adults;

(2) four hundred thousand dollars (\$400,000) to provide or contract for expanded home care programs or services for adults;

(3) four hundred thousand dollars (\$400,000) to

1 provide or contract for expanded attendant care programs and  
2 services for adults; and

3 (4) two hundred thousand dollars (\$200,000) to  
4 provide or contract for adult daycare statewide, to alleviate  
5 waiting lists at existing centers and to increase personnel and  
6 provide operational expenses for centers in communities without  
7 adult daycare.

8 B. One million dollars (\$1,000,000) is appropriated  
9 from the general fund to the human services department for  
10 expenditure in fiscal year 1997 to expand the Medicaid disabled  
11 and elderly waiver program and services.

12 C. Any unexpended or unencumbered balance remaining  
13 at the end of fiscal year 1997 shall revert to the general fund.
