MAKING AN APPROPRIATION FOR AN EDUCATION DEGREE PROGRAM AT THE
GALLUP BRANCH OF THE UNIVERSITY OF NEW MEXICO.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Two hundred fifty thousand
dollars (\$250,000) is appropriated from the general fund to the
board of regents of the university of New Mexico for expenditure
in fiscal year 1997 for the purpose of funding an education
degree program at the Gallup branch of the university of New
Mexico. Any unexpended or unencumbered balance remaining at the
end of fiscal year 1997 shall revert to the general fund.
