BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. GENERAL FUND--DEPARTMENT OF FINANCE AND
ADMINISTRATION--CHANGE IN PURPOSE-- APPROPRIATION. --The general
fund appropriation to the local government division of the
department of finance and administration for the construction of
football fields and other facilities at Bullhead park located in
Bernalillo county, pursuant to Subsection KKKKKK of Section 24
of Chapter 222 of Laws 1995, shall not be expended for its
original purpose but is appropriated to plan, design, construct
or equip a football field in Albuquerque located in Bernalillo
county. Any unexpended or unencumbered balance remaining at the
