AN ACT

RELATING TO CAPITAL EXPENDITURES; REAUTHORIZING UNEXPENDED OR UNENCUMBERED BALANCES; CHANGING THE PURPOSE OF A SEVERANCE TAX BOND AUTHORIZATION FOR THE PLACITAS COMMUNITY CENTER LOCATED IN DONA ANA COUNTY; EXTENDING THE PERIOD OF EXPENDITURE; MAKING AN APPROPRIATION; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. SEVERANCE TAX BONDS-- DEPARTMENT OF FINANCE AND ADMINISTRATION-- CHANGE IN PURPOSE-- APPROPRIATION. --The balance of the proceeds from severance tax bonds appropriated to the local government division of the department of finance and administration for adding a recreation room to the Placitas community center located in Dona Ana county, pursuant to Subsection YYYY of Section 9 of Chapter 148 of Laws 1994, shall not be expended for its original purpose but is reauthorized and
