BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Sixty thousand dollars
(\$60,000) is appropriated from the general fund to the
department of health for expenditure in fiscal year 1997 to
establish a parent outreach program in Crownpoint through the
Crownpoint health care facility in McKinley county. Any
unexpended or unencumbered balance remaining at the end of
fiscal year 1997 shall revert to the general fund.
