AN ACT

RELATING TO THE PUBLIC PEACE, HEALTH, SAFETY AND WELFARE; MAKING
AN APPROPRIATION TO REIMBURSE SANTA FE FAMILIES FOR DIVERSION OF
WATER FOR USE IN THE CITY OF SANTA FE LOCATED IN SANTA FE
COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Two million five hundred
thousand dollars (\$2,500,000) is appropriated from the general
fund to the office of the state engineer for expenditure in
fiscal years 1996 and 1997 for the purpose of reimbursing Santa
Fe families who have been deprived of the use of water that was
diverted for use by the city of Santa Fe located in Santa Fe
county. Any unexpended or unencumbered balance remaining at the
end of fiscal year 1997 shall revert to the general fund.

Section 2. EMERGENCY. --It is necessary for the public
peace, health and safety that this act take effect immediately.
