BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred thousand dollars

administration for expenditure in fiscal year 1997 for the  
purpose of purchasing educational computer systems and software  
for the Mesa Verde community center in Albuquerque, located in
