WHEREAS, hardware costs and standard residential and business rate classification may not reflect current telecommunication economics:

NOW. THEREFORE. BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the state corporation commission be requested to cooperate with the legislative science, technology, energy and defense conversion committee or other appropriate interim committee in studying policy, economic and technological constraints on distance learning, telemedicine and access to information and public services; and

BE IT FURTHER RESOLVED that the state corporation commission make recommendations to the legislature by December 1, 1996 for legislation needed to foster development of effective, efficient and economical telecommunications infrastructure and rate structure; and

BE IT FURTHER RESOLVED that copies of this memorial be transmitted to the state corporation commission.
