AN ACT
MAKING AN APPROPRIATION FOR THE PAYMENT OF PER DIEM FOR THE
MEMBERS OF THE LEGISLATURE, FOR THE COMPENSATION OF EMPLOYEES OF
THE LEGISLATURE, FOR THE LEGISLATIVE EXPENSE OF SUPPLIES,
EQUIPMENT AND SERVICES AND FOR THE LEGISLATIVE COUNCIL SERVICE;
DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. For the expense of the first special session of
the forty-second legislature, there is reauthorized and
appropriated from the unexpended cash balances remaining from
the appropriation for legislative session expenses set forth in
Subsections A, C, E and G of Section 2 of Chapter 1 of Laws 1993
the following:

1 (1) for the expense of the house of
2 representatives, one hundred twenty-nine thousand nine hundred
3 seventy-one dollars (\$129,971) to be disbursed on vouchers
4 signed by the speaker and the chief clerk of the house of
5 representatives;

6 (2) for the expense of the senate, one hundred
7 twenty-six thousand seven hundred forty-one dollars (\$126,741)
8 to be disbursed on vouchers signed by the chairman of the
9 committees' committee and the chief clerk of the senate; and

10 (3) for the expense of the legislative council
11 service, the joint billroom and the legislative switchboard,
12 seventy-five thousand dollars (\$75,000) to be disbursed on
13 vouchers signed by the director of the legislative council
14 service.

15 B. Following adjournment of the first special
16 session of the forty-second legislature, expenditures authorized
17 in this act shall be disbursed on vouchers signed by the
18 director of the legislative council service.

19 Section 2. EMERGENCY. --It is necessary for the public
20 peace, health and safety that this act take effect immediately.
