AN ACT

MAKING AN APPROPRIATION FOR PUBLIC SCHOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. Eight million dollars (\$8,000,000) or the amount remaining in the event a reduction is made pursuant to Subsection B of this section, is appropriated from the general fund to the state department of public education for expenditure in fiscal year 1997 for distribution through state equalization guarantee distribution for the purpose of increasing public school support.

B. If the superintendent of public instruction determines that the public school capital outlay council has agreed to consider applications by the Rio Rancho school

1 district and the Pecos school district for grant assistance from  
2 the public school capital outlay fund for the 1996-1997 school  
3 year, then twelve percent of the eight million dollar  
4 (\$8,000,000) appropriation set forth in Subsection A of this

6 for expenditure in fiscal year 1997.

7 C. Any unexpended or unencumbered balance remaining  
8 at the end of fiscal year 1997 shall revert to the general fund.
