PROPOSING TO SELL THE STATE RECORDS AND ARCHIVES PROPERTY AT 404 MONTEZUMA IN SANTA FE, SANTA FE COUNTY, NEW MEXICO.

A JOINT RESOLUTION

WHEREAS, Section 13-6-3 NMSA 1978 requires ratification and approval of any sale of real property by a state agency for a consideration of one hundred thousand dollars (\$100,000) or more; and

WHEREAS, the property control division of the general services department is desirous of selling real property and improvements, legal description set forth below; and

WHEREAS, the property control division proposes to sell the state records and archives property located at 404 Montezuma in Santa Fe county, New Mexico and more particularly described as:

Lots 120, 121, 122, 123, 163, 164, 165; portions of Lots 119, 124, 166 and 167; part of the alleyway

1	North of Lots 163, 167 and South of Lots 119, 124;
2	all of the alleyway North of Lots 164, 165, 166, 167
3	and South of Lots 120, 121, 122, 123; within
4	"Valuable Building Lots Adjoining Railroad Depot,
5	Santa Fe, New Mexico, 1880;" said property, taken
6	together, described by survey of W. G. Turley dated
7	January 23, 1959, amended May 15, 1959, as follows:
8	Beginning at the Northeast corner of this property,
9	whence the actual Southeast intersection of Guadalupe
10	Street and Montezuma Avenue bears Easterly 65.08 feet
11	distant; thence from said beginning corner, marked by
12	an iron stake, S. 30° 05.5′ W., 48.95 feet to a point
13	on the North side of a loading platform; thence S.
14	56° 37' E., 1.58 feet; thence S. 30° 43' W., 99.84
15	feet to a point; thence N. 60° 34′ W., 2.24 feet to a
16	point; thence S. 31° 14′ W., 7.43 feet; thence S. 32°
17	59' W., 26.30 feet; thence S. 35° 54' W., 26.30 feet;
18	thence S. 38° 59' W., 26.30 feet to the Southeast
19	corner of this property, whence the center of
20	sanitary sewer manhole cover at the intersection of
21	Garfield Street and Guadalupe Street bears S. 59° 53'
22	E., 89.4 feet distant; thence from said Southeast
23	corner N. 74° 28' W., 93.85 feet to a point for the
24	Southwest corner of this property; thence N. 19° 42'
	E., 115.45 feet to a point in the center of said

alley; thence S. 74° 28' E., 15.0 feet; thence N. 19° 42' E., 110.0 feet to a point on the Southerly side of said Montezuma Avenue; thence S. 74° 28' E., along said Avenue, 131.0 feet to the place and point of beginning.; and

WHEREAS, the property shall not be sold for less than the value of the property established by the taxation and revenue department using generally acceptable appraisal techniques for this type of property;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the proposed sale be hereby ratified and approved pursuant to the provisions of Section 13-6-3 NMSA 1978; and

BE IT FURTHER RESOLVED that a copy of this resolution be transmitted to the property control division of the general services department.
