**A MEMORIAL**

**REQUESTING THE UNITED STATES POSTAL SERVICE TO ESTABLISH A  
POST OFFICE IN THE VILLAGE OF LOS RANCHOS DE ALBUQUERQUE.**

**WHEREAS, the village of Los Ranchos de Albuquerque has a  
population of about five thousand six hundred people; and**

**WHEREAS, the nearest post offices are five miles to the  
north of the center of the village and eight miles to the  
south; and**

**WHEREAS, historically and socially, the village post  
office has served as the heart of the community; and**

**WHEREAS, the village has existed for forty years but has  
never had its own post office or zip code; and**

**WHEREAS, the fact that business mail destined for the  
village is actually addressed to Albuquerque hampers the  
village's business growth; and**

1           WHEREAS, about twenty percent of the population is over  
2 fifty-five and the elderly need a closer post office for  
3 reasons of health and security;

4           NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF  
5 REPRESENTATIVES OF THE STATE OF NEW MEXICO that the United  
6 States postal service be requested to establish a post office  
7 in the village of Los Ranchos de Albuquerque; and

8           BE IT FURTHER RESOLVED that copies of this memorial be  
9 transmitted to the United States postmaster general and to the  
10 New Mexico congressional delegation.
