A JOINT RESOLUTION

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. It is proposed to amend Article 7, Section 5 of the constitution of New Mexico to read:

"A. All elections shall be by ballot [and]. The person who receives the highest number of votes for any office, except as provided in Subsection B of this section, and except in the cases of the offices of governor and lieutenant governor, shall be declared elected [thereto] to that office. The joint candidates receiving the highest number of votes for the offices of governor and lieutenant governor shall be declared elected to those offices.

B. A municipality may, by ordinance, provide for
