WHEREAS, the retiree health care authority is desirous of
selling real property and improvements, legal description set
forth below; and

WHEREAS, the retiree health care authority proposes to
sell the retiree health care authority property located at 625
Don Gaspar avenue in Santa Fe county, New Mexico, and more
particularly described as:

Lots 21 and 22, Block 2 as shown on amended plat of
South Capitol Subdivision, City of Santa Fe, County

2 WHEREAS, the property shall not be sold for less than the
3 value of the property established by the taxation and revenue
4 department using generally acceptable appraisal techniques for
5 this type of property;

7 STATE OF NEW MEXICO that the proposed sale be hereby ratified
8 and approved pursuant to the provisions of Section 13-6-3 NMSA
9 1978; and

11 transmitted to the retiree health care authority.
