AN ACT

RELATING TO CAPITAL EXPENDITURES; AUTHORIZING THE ISSUANCE OF SEVERANCE TAX BONDS; REAUTHORIZING UNEXPENDED OR UNENCUMBERED BALANCES; CHANGING AGENCIES AND PURPOSES OF CERTAIN BOND AUTHORIZATIONS AND FUND APPROPRIATIONS; EXTENDING EXPENDITURE PERIODS; AUTHORIZING EXPENDITURES; MAKING APPROPRIATIONS; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. SEVERANCE TAX BONDS-- AUTHORIZATIONS-- APPROPRIATION OF PROCEEDS. --

A. The state board of finance may issue and sell severance tax bonds in compliance with the Severance Tax Bonding Act in an amount not to exceed the total of the amounts authorized for purposes specified in this act. The state board of finance shall schedule the issuance and sale of

1 the bonds in the most expeditious and economical manner
2 possible upon a finding by the board that the project has been
3 developed sufficiently to justify the issuance and that the
4 project can proceed to contract within a reasonable time. The
5 state board of finance shall further take the appropriate
6 steps necessary to comply with the Internal Revenue Code of
7 1986, as amended. Proceeds from the sale of the bonds are
8 appropriated for the purposes specified in this act.

9 B. The agencies named in this act shall certify to
10 the state board of finance when the money from the proceeds of
11 the severance tax bonds authorized in this section is needed
12 for the purposes specified in the applicable section of this
13 act.

14 C. If the specified agency has not certified the
15 need for the issuance of the bonds by the end of fiscal year
16 2001, the authorization provided in this act shall be void.

17 D. Unless otherwise specified in this act, any
18 unexpended or unencumbered balance remaining from the proceeds
19 of severance tax bonds issued pursuant to this act at the end
20 of fiscal year 2003 shall revert to the severance tax bonding
21 fund.

3 Section 3. ARMORY BOARD PROJECTS. --Pursuant to the

6 the bonds, the following amounts are appropriated to the state
7 armory board for the following purposes:

8 A. five hundred fifty thousand dollars (\$550,000)
9 to plan, design and construct a drainage water control system
10 and other improvements for the Onate complex infrastructure in
11 Santa Fe county; and

12 B. seven hundred seventy thousand dollars
13 (\$770,000) to renovate, repair and make improvements to
14 various armories located throughout the state.

15 Section 4. AUDITOR--PURPOSE. --Pursuant to the provisions
16 of Section 1 of this act, upon certification by the state
17 auditor that the need exists for the issuance of the bonds,
18 thirty-three thousand two hundred fifty dollars (\$33,250) is
19 appropriated to the state auditor to purchase furniture and
20 signage for the state auditor's office in Santa Fe in Santa Fe
21 county.

22 Section 5. CAPITAL PROGRAM FUND--PURPOSES. --Pursuant to
23 the provisions of Section 1 of this act, upon certification by
24 the property control division that the need exists for the
25 issuance of the bonds, the following amounts are appropriated

7 Subsection KKK of Section 9 of Chapter 7 of Laws 1998 to plan,
8 design, construct or equip a detoxification center to be built
9 near the detention facility complex in the city of Santa Fe in
10 Santa Fe county may be expended to plan, design, construct or
11 equip a detoxification center to be built near the law
12 enforcement complex in Santa Fe county.

13 Section 91. SANTA FE RIVER CHANNEL AND PARKWAY--CHANGING
14 THE PURPOSE. --Two hundred thousand dollars (\$200,000) of the
15 severance tax bond proceeds appropriated to the local
16 government division of the department of finance and
17 administration pursuant to Subsection NNNNN of Section 9 of
18 Chapter 148 of Laws 1994 to conduct field investigations
19 involving seismic analysis, soil borings and sampling and

1 Section 92. SANTA ROSA PUBLIC SAFETY BUILDING--EXPANDING
2 THE PURPOSE AND EXTENDING THE EXPENDITURE PERIOD.--The
3 severance tax bond proceeds appropriated to the local

5 administration pursuant to Subsection ZZZ of Section 5 of
6 Chapter 4 of Laws 1996 (1st S.S.) to plan and design a public
7 safety building in Santa Rosa in Guadalupe county may also be
8 expended to acquire land and construct a public safety
9 building. The period of time in which this appropriation may
10 be expended shall be extended through fiscal year 2002. Any
11 unexpended or unencumbered balance remaining at the end of
12 fiscal year 2002 shall revert to the severance tax bonding
13 fund.

14 Section 93. TATUM POLICE COMPLEX--CHANGING THE

6 be expended for that purpose but is appropriated to plan,

13 used to plan, design and construct a child visitation facility
14 for women at the penitentiary of New Mexico south in Santa Fe
15 county.

16 Section 97. WOMEN'S CORRECTIONAL INSTITUTION VISITATION
17 FACILITY--GENERAL FUND--CHANGING PROJECT LOCATION. --The
18 balance of the general fund appropriation to the capital
19 program fund pursuant to Subsection A of Section 14 of Chapter
20 118 of Laws 1998 to plan, design and construct an all-purpose
21 overnight family visitation center for children and their
22 inmate mothers at the New Mexico women's correctional facility
23 in Grants in Cibola county shall not be used for that purpose
24 but shall be used to plan, design and construct a child
25 visitation facility for women at the penitentiary of New

2 Section 98. PROJECT SCOPE--EXPENDITURES.--If an
3 appropriation for a project authorized in this act is not
4 sufficient to complete all the purposes specified, the
5 appropriation may be expended for any portion of the purposes
6 specified in the appropriation. Expenditures shall not be
7 made for purposes other than those specified in the
8 appropriation.

9 Section 99. CULTURAL AFFAIRS--GENERAL FUND
10 APPROPRIATION.--

11 A. The following amounts are appropriated from the
12 general fund to the office of cultural affairs for expenditure
13 in fiscal years 1999 through 2003 for the following purposes:

14 (1) one million five hundred thousand dollars
15 (\$1,500,000) to construct, equip, furnish and acquire exhibits
16 for the Anderson-Abruzzo international balloon museum in
Albuquerque in Bernalillo county; and

23 13-4A-4 NMSA 1978 and where applicable, the appropriations
24 authorized in this act include one percent for the art in
25 public places fund.
