17	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
18	SECTION 1. A new section of the Public Assistance Act is
19	enacted to read:

22	A. Consistent with the federal act and subject to
23	the appropriation and availability of federal and state funds,
24	the secretary shall establish a home visiting program to

The home 2 visiting program shall provide for at least six visits where home visiting services are provided to an infant or the 3 infant's family during the infant's first year of life. 4 As used in this section, "home visiting program" 5 Β. means a program that: 6 7 (1) uses home visiting as a primary service delivery strategy; 8 offers services to an infant and the 9 (2)infant's family that the infant's family receives on a 10 voluntary basis; 11 12 (3) provides a comprehensive array of services that: 13 (a) are designed to promote child 14 well-being and prevent adverse childhood experiences; 15 (b) promote parental competence and 16 successful early childhood health and development by building 17 long-term relationships with families and optimizing the 18 19 relationships between parents and children in their home 20 environments; and deliver a variety of informational, (c) 21 educational, developmental, referral and other supports to an 22 infant and the infant's family; 23 (4) is research-based and grounded in 24 relevant, empirically based best practices and knowledge that 25 .197322.1
