- 3. On page 1, line 16, after the second semicolon, insert:

"ALLOWING THE USE OF THE FUND FOR RELEVANT STATEWIDE ECONOMIC DEVELOPMENT FINANCE ACT AND LOCAL ECONOMIC DEVELOPMENT ACT PROJECTS; REQUIRING AGENCY APPROVAL;".

- 4. On page 2, between lines 1 and 2, insert:
- "A. "agency" means the department of environment and the office of the state engineer working jointly to implement and enforce the provisions of the Strategic Water Supply Act;".
 - 5. On page 2, line 11, before "political", insert "other".
- 6. On page 2, line 22, after the comma, strike the remainder of the line and strike line 23 and on line 24, strike "or" and insert in lieu thereof "the agency may".
- 7. On pages 3 and 4, strike Subsections B and C in their entirety and insert in lieu thereof:

 - 11. On page 5, line 9, strike ", contract".
 - 12. On page 5, line 11, strike "contract or".
 - 13. On page 5, line 12, strike "or D".
 - 14. On page 5, between lines 14 and 15, insert:
- "F. In connection with any strategic water supply program grant that is subject to the notice of intention filing requirements pursuant to Section 72-12-26 NMSA 1978, the office of the state engineer shall provide an opportunity for a federally recognized Indian nation, tribe or pueblo located wholly or partially in New Mexico, an individual, a firm, a corporation or other entity to file an objection or protest through a process consistent with the provisions of Section 72-12-3 NMSA 1978 regarding a determination by the state engineer made pursuant to Section 72-12-26 NMSA 1978.".
 - 15. Reletter subsections to correspond with these amendments.
 - 16. On page 5, between lines 22 and 23, insert:
- "B. The fund may be used to support relevant State Economic Development Finance Act and Local Economic Development Act
