11	RELATING TO ANIMALS; CREATING THE ANIMAL WELFARE PROGRAM TO
12	PROVIDE FUNDING FOR PROJECTS THAT SUPPORT THE WELFARE OF
13	DOMESTIC CATS AND DOGS; CREATING THE ANIMAL WELFARE TRUST FUND
14	AND ANIMAL WELFARE PROGRAM FUND; MAKING AN APPROPRIATION;
15	PROVIDING FOR A TRANSFER FROM THE GENERAL FUND TO THE ANIMAL
16	WELFARE TRUST FUND.

18	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
19	SECTION 1. [<u>NEW MATERIAL</u>] ANIMAL WELFARE PROGRAM
20	A. The "animal welfare program" is created to
21	provide funding for projects that support the welfare of
22	domestic cats and dogs as provided in this section. Beginning
23	July 1, 2028, the department may award a grant to a
24	municipality or county, or contract for services with an
25	eligible entity, for a project to repair, renovate or operate

2	services for:
3	(1) controlling loose or stray cats and dogs
4	to mitigate threats to public safety, livestock or other
5	domestic animals;

8	of animal cruelty;
9	(3) reducing animal shelter intake and
10	euthanasia rates or expanding animal shelter building facility

applicant shall apply to the department on forms and in a manner prescribed by the department. An application shall include:

(1)

(2) a demonstration that the proposed project will meet one or more of the purposes provided in Subsection A of this section; and

a description of the proposed project;

(3) details and specifics as to the reasonable expected costs and completion date of the proposed project.

The department shall determine, through a C. competitive review process pursuant to rules promulgated by the department, which proposed projects are approved to receive a grant or contract for services. The department may adjust the amount of money requested for a proposed project based on its determination of the reasonable costs of the proposal or on the availability of funds available for the fiscal year for the animal welfare program. Once the projects are approved, the department shall promptly offer each applicant a grant or contract for services, as appropriate. If a grantee or contractor accepts an offer, the project may commence and the grantee or contractor shall report to the department on the progress of the project on a periodic basis, as determined by the department, including an accounting of expenditures made for the project. Funds allocated to an approved project shall be spent within two years of receiving a grant or contract for .228806.4

1 services, and if any unexpended or unencumbered balance remains 2 at the end of the project period, the applicant shall 3 immediately return that balance to the department. The 4 department shall deposit returned amounts in the animal welfare 5 program fund. The department shall promulgate rules to 6 D. 7 administer the animal welfare program. The rules shall include 8 provisions to: 9 (1) establish procedures for review, 10 evaluation and approval of proposed project applications; 11 (2) accord priority attention to areas with 12 the greatest need for animal welfare projects; and 13 evaluate the ability and competence of an (3) 14 applicant to provide efficiently and adequately for the 15 completion of a proposed project. 16 Beginning October 1, 2028 and each October 1 Ε. 17 thereafter, the department shall submit a report to the 18 legislative finance committee on the animal welfare program 19 that shall include: 20 for each funded project: (1) 21 a description of the project; (a) 22 the name of the grantee or (b) 23 contractor; 24 (c) how much funding the project 25 received; .228806.4 - 4 -

As used in this section: 12 "department" means the department of (1) 13 finance and administration; 14 (2) "eligible entity" means a nonprofit 15 organization whose primary purpose is to provide services that 16 support the welfare of domestic cats and dogs; and 17 "equipment and supplies" means vehicles, (3) 18 equipment and tools, computer hardware and software, training 19 materials and supplies that are necessary and directly related 20 to providing support for animal welfare. 21 SECTION 2. [NEW MATERIAL] ANIMAL WELFARE TRUST FUND .--22 The "animal welfare trust fund" is created as a Α. 23 nonreverting fund in the state treasury. The fund consists of 24 distributions, appropriations, gifts, grants and donations. 25 Income from investment of the fund shall be credited to the .228806.4

1 fund. Money in the fund shall be expended only as provided in 2 this section.

B. The state investment officer, subject to the approval of the state investment council, shall invest money in the animal welfare trust fund:

(1) in accordance with the prudent investorrule set forth in the Uniform Prudent Investor Act; and

8 (2) in consultation with the department of9 finance and administration.

C. The state investment officer shall report quarterly to the legislative finance committee and the state investment council on the investments made pursuant to this section. Annually, a report shall be submitted no later than October 1 to the legislative finance committee.

D. On July 1, 2028 and each July 1 thereafter, a distribution shall be made from the animal welfare trust fund to the animal welfare program fund in an amount equal to five percent of the average of the year-end market values of the trust fund for the immediately preceding three calendar years.

SECTION 3. [<u>NEW MATERIAL</u>] ANIMAL WELFARE PROGRAM FUND.--The "animal welfare program fund" is created in the state treasury. The fund consists of appropriations, gifts, grants, donations and income from investment of the fund. The department of finance and administration shall administer the fund, and money in the fund is appropriated to the department .228806.4

Any unexpended or unencumbered balance remaining at the end of a fiscal year shall revert to the animal welfare trust fund.
