AN ACT

RELATING TO CRIME VICTIMS; AMENDING THE CRIME VICTIMS REPARATION ACT; INCLUDING ASSAULT, BATTERY, CRIMINAL SEXUAL CONTACT AND ARMED ROBBERY AS ENUMERATED OFFENSES FOR WHICH REPARATION TO VICTIMS MAY BE MADE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 31-22-8 NMSA 1978 (being Laws 1981, Chapter 325, Section 8, as amended) is amended to read:

"31-22-8. CRIMES ENUMERATED. --

- The crimes to which the Crime Victims Reparation Act applies and for which reparation to victims may be made are the following enumerated offenses and all other offenses in which any enumerated offense is necessarily included:
  - arson resulting in bodily injury; (1)
  - assault, aggravated assault, battery or (2)
