17	SECTION 1. A new section of Chapter 66, Article 3 NMSA
18	1978 is enacted to read:
19	"[ <u>NEW MATERIAL</u> ] SUICIDE PREVENTION SPECIAL REGISTRATION

21	A. Beginning January 1, 2026, the division shall
22	issue a standardized special registration plate with a logo
23	designed as specified in Section 66-3-424 NMSA 1978 to express
24	support for suicide prevention.
25	B. For a fee of thirty-five dollars (\$35.00), which

shall be in addition to the regular motor vehicle registration fees, a motor vehicle owner may apply for issuance of a suicide prevention special registration plate. The owner shall pay a renewal fee of thirty dollars (\$30.00) each year to retain and renew the special registration plate.

C. Revenue from the fees imposed by Subsection B of this section shall be distributed as follows:

(1) twelve dollars (\$12.00) of the initial fee collected for each registration plate shall be retained by the department and is appropriated to the department for the manufacture and issuance of the special registration plates; and

(2) the remaining portion of the initial fee and the entire renewal fee collected for each registration plate shall be distributed to and is appropriated to the behavioral health services division of the health care authority to support suicide prevention efforts.

D. Beginning on July 1, 2031, and on July 1 of each subsequent year, the department may compare the number of suicide prevention special registration plates issued and renewed in the previous fiscal year with the average number of such plates issued and renewed annually between fiscal years 2026 through 2031. If the department determines that the number of suicide prevention special registration plates issued and renewed in the previous fiscal year is less than fifty .230890.1
