The Department has received your letter dated April 21, 2016 with regard to the classification of audit findings numbered 2015-002 and 2015-003 that ACE Leadership High School received in the Fiscal Year 2015 audit. After discussion with Pattillo, Brown & Hill, LLP and Axiom, LLC, it is clear the audit findings noted in the fiscal year 2015 audit should have been classified as a significant deficiency and compliance violation rather than a material weakness and significant deficiency.

For purposes of the corrective action plan, generate and submit the corrective action plan based on the findings classified as a significant deficiency and a compliance violation. The Department will be conducting a review of the submitted corrective action plan and implementing follow up procedures to ensure that the charter school is implementing the steps necessary to clear the audit findings.
