

# **Outstanding Capital Funds Total \$3.1 Billion**

At the end of the third quarter of FY23, outstanding capital outlay funds totaled an estimated \$3.1 billion, including projects authorized by the Legislature through 2022 (\$1.8 billion), earmark projects (\$258 million), supplemental severance tax bonds for public schools (\$463.8 million), and special appropriations to capital projects (\$605.6 million). The last figure represents uncommitted and unspent funds from \$977.4 million in special appropriations during the 2021 special and 2022 regular sessions.

# **Key Points**

- Among three major categories of capital outlay, local projects have the most outstanding funds and slowest expenditure rates, with \$815.6 million outstanding or 62 percent of 2019 to 2022 appropriations (See Table 1). Statewide projects have spent funds more quickly, with 49 percent of appropriations outstanding, respectively. Excluding general obligation bond (GOB) projects for which funding just became available, higher education projects have also spent funds more quickly, with 56 percent of appropriations outstanding.
- Roughly 4,000 active projects are underway, with the number likely to rise to around 5,000 this summer.
- 2022 projects funded with general obligation bonds are now included in LFC tracking. Bonds for 106 projects totaling \$258.3 million were sold this spring. Bonds for one approved project – a \$457 thousand appropriation for the Whispering Pines Senior Center in Bernalillo County – were not sold because the county chose not to pursue the project due to uncertainty regarding the facility's water supply.
- Excluding the new GOB projects, outstanding capital funds were spent down by an estimated \$397 million in the third quarter of FY23, driven by the expenditure of \$180.5 million for projects authorized by the Legislature and the expenditure or encumbrance of \$140.5 million for special appropriations from 2021 and 2022 special and regular sessions.

LFC QUARTERLY REPORTS provide analysis on the progress of capital appropriations.

Data is derived from the Department of Finance and Administration, state and local entities, and the Capital Project Monitoring System. Outstanding balances reported in this memo reflect expenditures as of March 2023 and do not include encumbered but unspent funds, with the exception of balances reported for special appropriations.

#### 2023 Capital Appropriations and Related Legislation

The 2023 capital outlay bill authorized \$1.2 billion from the general fund and other state funds for nearly 1,500 state and local infrastructure projects. The governor vetoed only three appropriations from the bill totaling \$260 thousand.

The 2023 capital package was the largest in the state's history. Nevertheless, capital outlay requests from state and local entities continued to exceed available funding. Requests totaled an estimated \$4.8 billion, including \$3.7 billion submitted for direct appropriations from House and Senate members and \$1.1 billion submitted through the state agency and higher education request processes. The requests from local entities exceeded unfunded needs for priority projects in FY24 identified on local infrastructure capital improvements plans by about \$1 billion.

The significant gap between need and available funds, along with the practice of earmarking funding for individual legislators and the governor, undermines the state's ability to use surging revenues to efficiently complete projects that represent the greatest needs or would produce the most public benefits. Local projects are not consistently vetted for need or readiness and often receive only piecemeal funding. Piecemeal funding can contribute to project delays and increase overall costs. Approximately 38 percent of nearly 1,400 local projects authorized in the 2023 capital bill received 50 percent or less of requested funds, with \$191.3 million appropriated to 552 projects for which \$1.4 billion was requested.

The absence of a state entity responsible for coordinating capital outlay with other available funding sources and assisting local entities in accessing those funds exacerbates these delays. An LFC-endorsed bill (Senate Bill 197) to create such a coordinating entity failed to receive a committee hearing in the 2023 session.

## **Project Management Capacity**

The \$1.2 billion in 2023 appropriations come just a year after special and regular sessions in which more than \$2 billion was appropriated to capital projects. These historically large investments in capital projects come at a time when supply chain and labor issues, rising construction costs, and state and local capacity limitations have made it more difficult to efficiently complete projects. House Bill 2 included recurring and nonrecurring appropriations to increase capacity to spend down capital funds and complete projects. The appropriations support 19 new full-time positions and contract support in five state agencies and the continuation of a new grant program to build project management and grant writing capacity at the local level.

#### Paying for Capital Projects with Cash

A surplus of nonrecurring general fund revenues allowed the Legislature to use cash for 2023 capital projects rather than rely on bonding. Paying cash generates long-term savings by eliminating the cost of interest. Additionally, the severance tax revenues that would typically be dedicated to paying down

debt can instead be transferred to the severance tax permanent fund to increase recurring general fund revenue in future years. Passage of Senate Bill 378 ensured the state will realize this benefit by requiring an annual distribution of \$92 million from the severance tax bonding fund to the severance tax permanent fund for 10 years, an amount equal to the long-term debt service avoided by not issuing severance tax bonds for capital outlay.

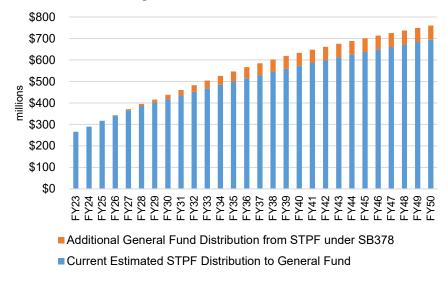
Continued general fund surpluses are likely to give the Legislature the option of cash financing capital projects again in 2024 and of sending additional infusions to the severance tax bonding fund for future benefit.

### Reversion Risk for General Fund Projects

For several years, the capital outlay bill has included language requiring entities to encumber 5 percent of general fund appropriations within the first fiscal year. If entities that received general fund capital appropriations in the 2022 session do not encumber 5 percent by June 30, the unexpended balances of those appropriations should revert to the general fund. As of early May, 30 projects from 2022 with \$20 million in general fund appropriations had zero encumbrances and were at risk of reversion (see **Attachment E**). The projects were all in tribal communities because projects included in a \$30 million 2022 tribal infrastructure package sponsored by the governor received general fund appropriations while the remainder of the bill used severance tax bonds and other state funds. Next year, many more projects are likely to be at risk of reversion since general fund accounted for \$1.07 billion of 2023 capital appropriations. The Department of Finance and Administration (DFA) is working with the Indian Affairs Department to assist entities with encumbering funds before the deadline.

### **Staff Interim Work**

• LFC will continue to collaborate with DFA staff to identify opportunities to improve the rate of project completion and increase the odds that capital spending results in tangible improvements to public services and quality of life. The goal is to bring options requiring legislative action to the committee by late summer. Areas of focus include streamlining state agency administration of local capital appropriations, funding navigation and project management support, local capacity building, and improved project vetting support for legislators.

- Additionally, LFC and DFA staff are continuing to work with members of the Water Task Force on solutions specific to water and wastewater systems.
- A new reporting system for capital projects is scheduled to come online in the next month to replace the Capital Project Management System (CPMS). LFC participated in the design of the new system to improve the quality of reporting and increase staff's ability to provide more timely and systematic information to the Legislature on project bottlenecks and spending outcomes.
- Staff will provide the committee with analysis and tracking of construction cost trends for different facility types in New Mexico and neighboring states to inform 2024 appropriations and LFC participation in entities like the Public School Capital Outlay Council and Higher Education Capital Outlay Review Council.
- Staff plan to add in-depth project reviews and topical reports to current reporting to the committee with increased staff capacity in FY24.

# **\$1 Million and Greater Report (Attachment A)**

LFC conducts regular oversight of funded projects through quarterly reports to the committee. The reports include updates on individual projects funded for more than \$1 million and somewhat less frequent updates on individual projects funded for between \$250 thousand and \$999 thousand. Reports on individual projects include blue, green, yellow, and red ratings (see sidebar).

- Projects funded for \$1 million or more were most recently updated and rated by LFC staff based on March 2023 data. In that report, LFC staff tracked 557 active capital appropriations and 24 recently closed appropriations (see Table 5, page 10). A total of \$2.5 billion was appropriated to these projects, with unexpended balances of approximately \$1.6 billion.
- 309 projects were rated green and considered on schedule.
- 126 projects were rated red, indicating no progress, no reporting, significant delays or obstacles to completion, or recent reauthorization (see Table 4, page 6).
- 122 projects were rated yellow and considered behind schedule or facing some challenges but still progressing.

## **Progress on Major State-Owned Projects**

- The new State Police crime lab and secure storage facility in Santa Fe is substantially complete and the new District 1 Headquarters is nearly complete and will be occupied this summer. The total project cost for the crime lab and secure storage facility was approximately \$47 million (\$623 per square foot) and the total cost of the District 1 headquarters was approximately \$10 million (\$694 per square foot).
- Construction of the New Mexico Veterans' Home small homes project is proceeding on schedule and on budget, with the first three homes

expected to be completed this fall. The total project cost is approximately \$57 million (\$945 per square foot).

- General Services Department staff took a request to downgrade the historic status of the casitas on Don Gaspar Ave. before the Santa Fe Historic Review Board in May. The board downgraded the casitas from "significant" to "contributing" but upgraded the status of the Ortiz y Pino building from "non-contributing" to "contributing." GSD staff considered this a favorable outcome, though they requested all buildings be designated "non-contributing." GSD expects to take a request to demolish the buildings to the board later this summer to enable construction of the executive office building on the site. The Legislature appropriated \$85 million to the project and GSD entered into a \$9.8 million contract with an architect for design in April.
- Several major UNM Health Sciences Center projects are under construction:
  - The new hospital tower, which will add 96 new inpatient beds to the hospital's capacity as well as emergency care and 18 operating suites, is proceeding and expected to be complete in 2024. The total project cost is \$752 million (\$1,092 per square foot), \$30 million of which was state funding.
  - The new College of Nursing and Public Health Excellence building is also under construction with a 2024 completion date. The building will include classrooms, community space, and research labs and related renovations that have been completed or are underway on campus will expand and improve clinical opportunities for students. The projects are intended to support expanded enrollment in nursing programs. The total project cost is \$43 million (\$457 per square foot), \$32.5 million of which was state funding.
  - In partnership with Bernalillo County, a crisis triage center is under construction on the hospital campus, with completion expected this year. The project is being funded with county behavioral health tax revenues and UNMH funds at a total cost of \$40 million (\$821 per square foot). The facility is next to UNM's adult psychiatric hospital and will operate under a "no wrong door" model where patients will be assessed and connected to the appropriate level of care.

### **Earmark Funds**

The status of projects funded through the Water Trust Board (Attachment B), the Colonias Infrastructure Board (Attachment C), and the Tribal Infrastructure Fund (Attachment D) are summarized in the respective attachments.

#### Authorized But Unissued Projects (Attachment F)

Attachment F provides a list of projects authorized by the Legislature for which severance tax bonds have not yet been sold. Projects may not have been sold due to lack of audit compliance or because grantees have not certified readiness to proceed. As of May 2023, a total of \$37.7 million for 97 projects was authorized but unissued.
