- Important as part of the higher ed funding formula







Race & Ethnicity New Mexico vs. C2C Programs






PROJECT OUTLINE

- Replaces a 50+ year very outdated "cottage" model that has substantial limitations in managing behavioral health ICU patients without disrupting others services.
- The new facility addresses the fragmented buildings, better ICU care, more space for recovery and other programming, and more efficiencies in care.
- Upgrade the programming and state-wide telehealth support to patients and families in their communities to support the coordination of pre/post hospitalization.



PROJECT OUTLINE

- Project will increase the capacity and square footage of available space for student simulation activities and meet increasing needs for simulation, especially as the College of Nursing increases their enrollment.
- Creates the opportunity for greater inclusion of all HSC learners, including Graduate Medical Education.
- This project allows state-of-the-art simulation education adjacent to the classrooms of the HSC.
- This expansion will help to address the growing need for nurses, physicians, physician assistants, and emergency medicine personnel both in Bernalillo and Sandoval counties, and across the state.





Overview NM Workforce Analysis: Primary Care Physicians and RNs & CNSs






College of Nursing Highlights


- •Undergraduate Nursing program ranked 43rd out of 700 placing it in the top 6%of all bachelors of science in nursing programs in the nation as reported by *U.S.News & World Report's 2022 edition of Best Colleges*
 - Master of Science in Nursing (MSN) ranks 3rd in the Mountain West Region U.S.News & World Report's 2022
 - Master of Science in Nursing Nurse-Midwifery Concentration ranks 11th Nationally U.S.News 2022
- Direct Entry Freshman Admission BSN program continues to increase enrollment.
 - In Fall 2021 the CON admitted 33 new students.
- In FY 2021 the CON graduated 150 new BSN nurses.
- •New BSN students in Fall 2021 = 129 and anticipated new Spring 2022 enrollment = 96 (225)
 - BSN: NCLEX pass rates remain high at 97% on the first attempt (RN License).
- APRN / MSN: Admitted 46 new professional graduate students (NP). Also Post Masters Certifications (PMC)
 - APRN/MSN: Pass Rates remain high at 100%
- Doctor of Nursing Practice: Due to new AACN accreditation requirements all NP programs must move to a DNP (Doctor of Nursing Practice) in 2023 adding an additional year of instruction.
- •Health Sciences Rio Rancho (2018 year expansion) capital projects/expansion simulation center HSRR scheduled completion end of Fall 2021 and will offer augmented reality for immersive clinical experiences.







- **Epidemics or outbreaks** infectious diseases (cholera, influenza, polio, HIV, Covid), new illnesses, health behaviors, & disaster responses (biological warfare, 911, flooding, droughts.
- **Prevention of Chronic Diseases** Diabetes, Mental Health, Addiction, Heart Disease, memory difficulties, etc
- Population based perspective: Understanding the problem, what is the cause / risk factors, intervention evaluation, and implementation
- Public Health Service / Community Health Workers
- Address Social Determinants of Health and Social Justice to enhance Health as well as education, job training, and safety
- An All UNM effort leverage all our assets, such as Engineering, Business, Education, Rainforest, Environmental Health / Climate Change, Diverse Populations, etc





FY23 Legislative Session I&G Funding Needs

- Compensation increase of at least 7% for HSC faculty and staff
 - SOM currently has a gap of \$16.2M to reach 50th percentile for faculty
- Increased faculty in CON to support increasing the BSN program by 96 students per year (\$5M) and the APRNs by 60 (\$3M): Total \$8M
- SOM and COP faculty increases to address Behavioral Health (addiction and mental illness) and Health Equity (population health and data science): \$4 million
- Increase faculty in the COPH by 11 from the current 13 faculty
 - Needed for CEPH accreditation and to address a biostatistics deficit
 - Supports community health research and more undergrad & grad students:
 \$4.1M

Project ECHO

Total Request: \$ 6,537,500

Expansion Request: \$ 4,000,000

Current Program

- Supports the state's priorities in behavioral health, diabetes, substance use disorders, hepatitis C, child wellbeing and education, and in COVID-19 preparedness
- Provides access to evolving best practice in education and medicine to all 33 counties
- Provided COVID-19 related trainings to primary care providers across the state
- Expansion funds will increase support for
 - Ongoing infrastructure
 - Faculty time to operate existing ECHO programs
 - Offering new programming to support workforce development in education and healthcare
 - Expanding access to specialty care post-pandemic throughout the state



Office of the Medical Investigator (OMI)

Total Request: **\$7,264,600**

Expansion Request: \$1,723,000

- Current Program
 - Performs autopsies and investigates unattended deaths
 - In 2020, OMI investigated 9,800 deaths and examined 3,812 decedents
 - State appropriations covered 45% of OMI's budget
- Expansion funding will
 - Increase state appropriation to cover 55% of operating expenses
 - Support an additional Forensic Pathologist
 - Support forensic Toxicology for "Non-Pending" cases

Office of the Medical Investigator (OMI) Grief Services Program

Total Request: **\$267,100**

Expansion Request: \$64,500

Current Program

- The OMI Grief Services Program provides grief and trauma support to families dealing with a death investigation
- Focuses on populations that are at risk for a particularly complicated/traumatic grief
- During the pandemic, a Telehealth program was implemented, which prevented service interruption
- Expansion funding will
 - Restore funding decreases over the past two years
 - Support modest increases in staff salaries and professional contracts funds
 - Address the shortfall the program will be left with at the end of FY22

Comprehensive Movement Disorders Center

Total Request: **\$759,000**

Expansion Request: \$485,500

- Current Program
 - The Nene and Jamie Koch Comprehensive Movement Disorder Center at UNMH (CMDC) is the only clinic in New Mexico providing expert, comprehensive, multidisciplinary, subspecialty care and management of Parkinson disease and other movement disorders
 - The UNM CMDC brings clinical trials, research, educational, and employment opportunities to NM
- Expansion funding will support
 - Salaries for 3.4 more faculty FTE and 2.8 staff FTE
 - Community-based statewide education and training programs:
 - Movement Disorder fellowship program to locally train movement disorder neurologists
 - Educational program to train other providers in the management of movement disorders
 - Establishment and expansion of telehealth program for this population
 - The UNM CMDC Research, Tele neurology Outreach, and Advanced Therapeutics Programs


New Mexico Poison and Drug Information Center (NMPDIC)

Total Request: \$1,809,000

Expansion Request: \$305,300

- NMPDIC is New Mexico's Poison Center and is nationally accredited
 - Current Program
 - Provides expert 24-hour assistance to the residents of New Mexico during potential poisoning emergencies and educates HSC pharmacy and medical students and residents in the field of clinical toxicology
 - Expansion funding will
 - Restore recent General Fund and Tobacco Settlement cuts
 - Support a healthcare educator position
 - Received \$125,000 for FY22 (Junior Bill recurring appropriation)

Graduate Medical Education (GME)

Total Request: **\$2,291,700**

Expansion Request: \$294,500

Current Program

- Funds a total of 23-27 residency FTEs for FY22
 - Internal Medicine, Surgery, Family and Community Medicine (FCM), and Psychiatry, as well as other programs for rural and community rotations.
- Expansion funding will
 - Maintain residency positions in Internal Medicine, Surgery, Family and Community Medicine, and Psychiatry
 - Grow residency rotations to rural and community-based locations, facilitating rotations for such programs as obstetrics/gynecology, emergency medicine, palliative care, and infectious disease
 - Cover anticipated annual increase in salary + fringe expenses for our residents and fellows
 - Restore \$35,000 cut from the prior year



Minority Student Services Building STEAM-H Students (BOSS)

Total Request: **\$250,000**

Expansion Request: \$83,200

- Current Program
 - Provides STEAM-H educational opportunities for K-12 level African American students statewide (Bernalillo, Sandoval and Valencia counties)
- Expansion funding
 - Restores \$27,800 in program cuts since FY17
 - Will support a new Program Coordinator and expanded programing

Total Request: **\$313,900**

- Current Program
 - Program goal is to increase the number of Native American students that graduate in STEM-related fields at UNM

- A Student Success Coordinator

Communities to Careers/Pipeline Program

- RPSP Funding Request: \$ 300,000
 - Project is committed to growing New Mexico's diverse health care workforce
 - Provides underrepresented and underserved learners throughout New Mexico with programs, resources and partnerships aimed at pathways to health careers
 - Program was defunded in FY21
 - Received \$75,000 for FY22 from Junior Bill (recurring appropriation)

Collaborative to Increase Health Personnel to Medically Underserved Areas

- RPSP Funding Request: \$ 163,400
 - Project aims to increase the number of School of Medicine, College of Pharmacy, and College of Nursing graduates of who pursue careers providing care in NM's underserved communities
 - Funding would support program personnel, didactic training, travel and housing for community/rural rotations
