Office of Guardianship (OOG)

- Adult guardianship and legal services to income-eligible New Mexicans with disabilities
- Additional guardianship oversight duties (HB 234, 2021)

Office of the Special Education Ombud (OSEO)

- Established in 2021
- Advocates with students with disabilities and their families to obtain individualized educational services in public schools

Guardianship Snapshot

- 1003 protected persons currently receiving guardianship services funded by OOG
 - 987 protected persons served on June 30, 2022
- 114 guardianship cases in process
 - 82 professional guardianship cases
 - 32 family guardianship cases
- 139 applicants on OOG waitlist
 - 74 professional guardianship applications
 - 65 family quardianship applications
- 7 emergency & priority cases
 - 22 emergency & priority cases since July 1, 2022

OOG FY21 Rate Study

- Professional guardians \$900K & \$600K
 - \$325 (per month per protected person) -> \$395
 - \$395 (per month per protected person) -> \$445
- Treatment guardians \$158K
 - \$85 (per month per protected person) -> \$115
- Legal professionals \$15K
 - Court visitors: \$325 -> \$350
 - Guardians ad litem: \$650 -> \$665
 - Petitioning attorneys: \$900 -> \$925

- From December 1, 2021, to September 15, 2022, OSEO served 165 families in 29 school districts and 19 counties in every region across the state.
 - Advocated with students and families at over 70 meetings
 - Shared information and resources, answered questions, and reviewed options for next steps with students and families.
- OSEO developed a 16-hour initial training for volunteer ombuds, followed by shadowing, hands-on training, and supervised casework. OSEO has recruited and is currently training 7 volunteer ombuds.
- From December 1, 2021, to September 15, 2022, OSEO completed 24 presentations to hundreds of people across the state, including students, families, teachers, administrators, special education directors, and superintendents.
