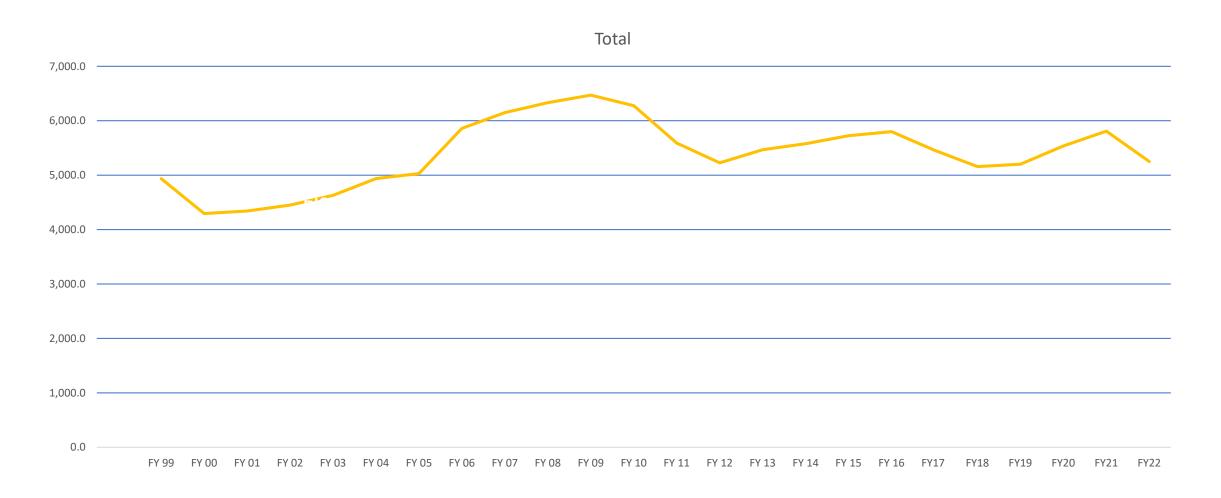

Note: All agencies were required to submit their FY22 budget request with a reduction of 5%, therefore our budget was reduced by \$273,900

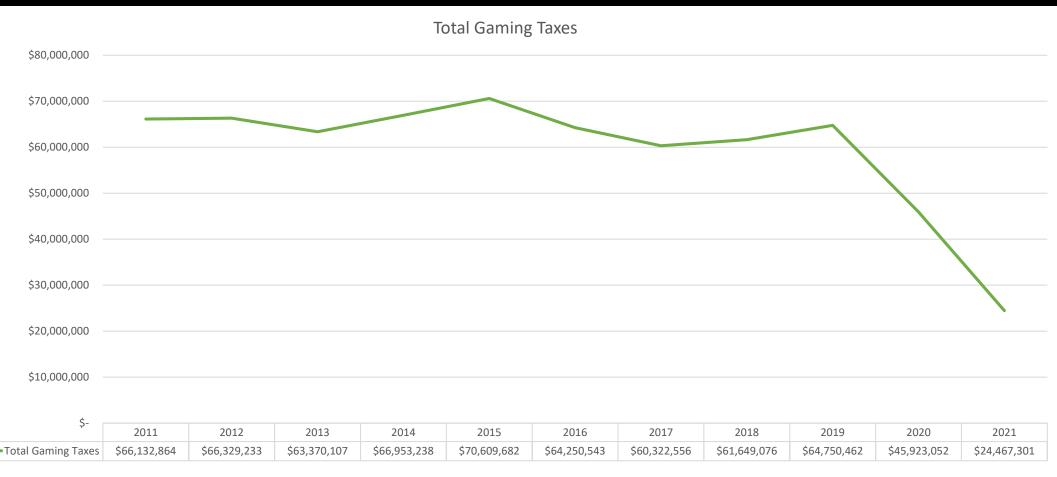
Reversion for FY20:

^{**}We applied a credit of \$406,000 that we had with a vendor against one of our contracts, thus increasing our reversion to \$430,800.

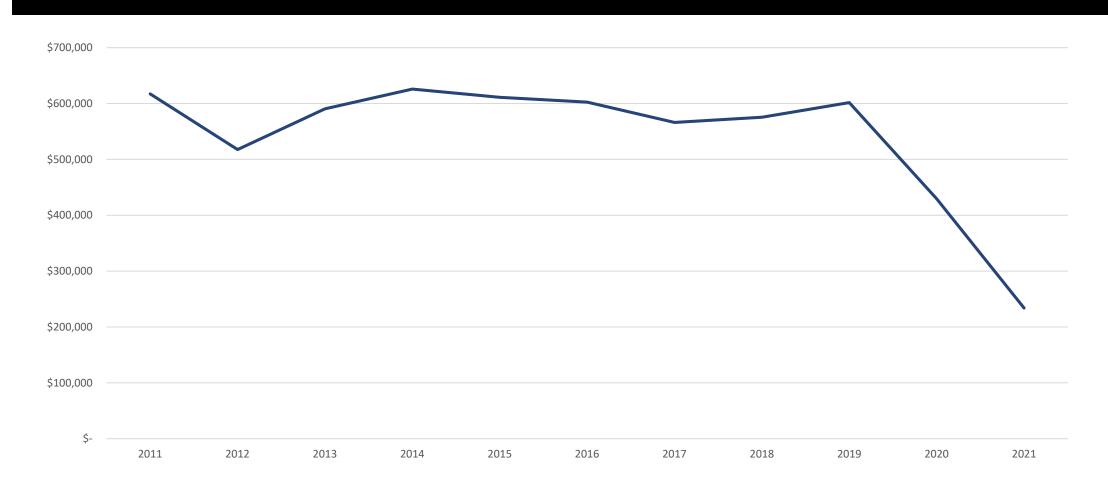

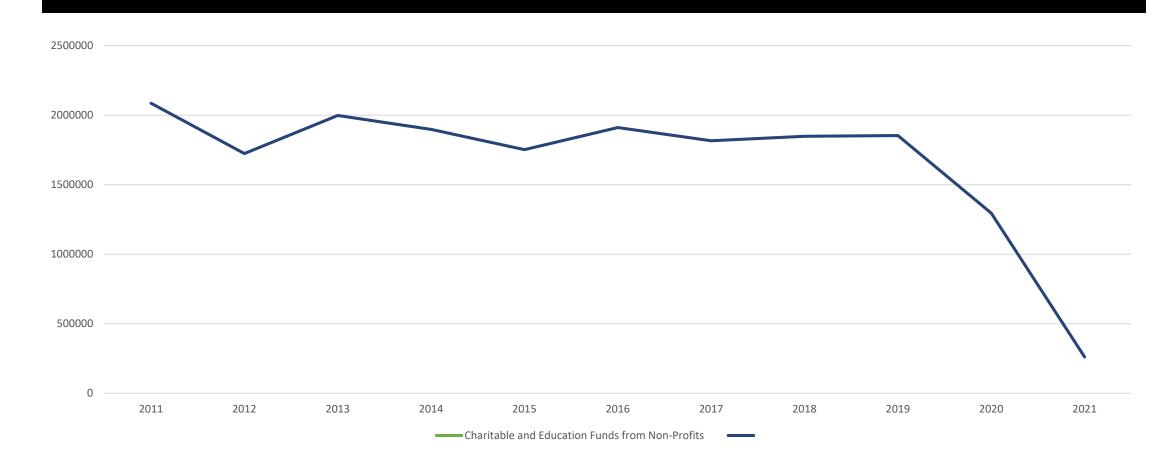
Gaming Tax 2011 – 2021 Racetracks, Non-Profits, Manufacturers, and Distributors



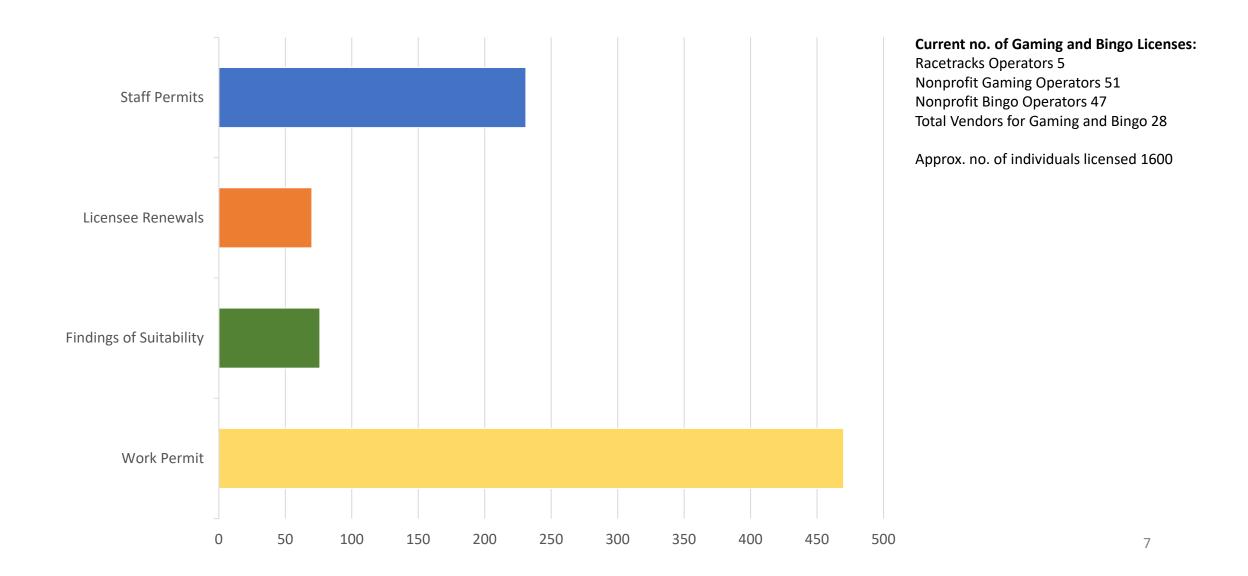
Problem Gambling Funds from Racetracks



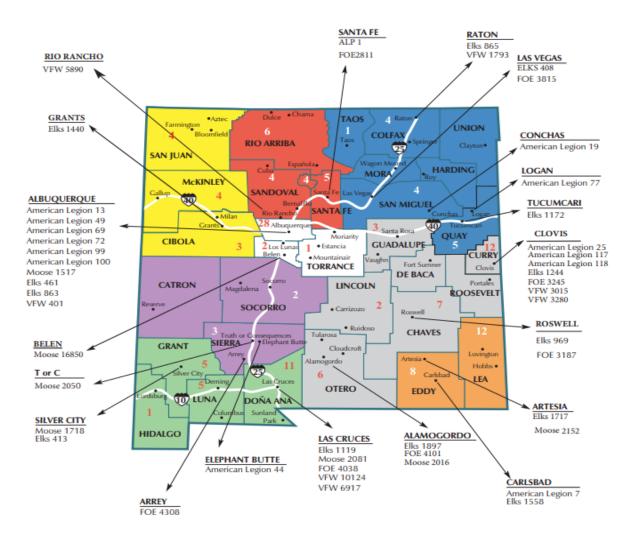
Charitable and Education Funds from Non-Profits

The Request for an Increased Budget: FY23

- We want to ensure compliance with laws and regulations for our agency.
 - Standard Operating Procedures
- We cannot regulate the state with only 39 employees (25% vacancy). We are seeking to fill vacancies and add 6 additional FTE's.
- We want to better manage workload and retention.
- We want to do more and at the same time develop creative methods to better serve the state:
 - Assign one agent to every racetrack
 - Focus on illegal poker games and online gaming
 - Prosecute our own criminal cases
 - Conduct more risk-based audits of racetrack casinos
 - Conduct software verifications of all nonprofits and racetrack casinos
 - Complete more Bingo risk-based audits
 - Travel the state to put on workshops for racetracks, nonprofit gaming and bingo
 - Research and revise all applications and forms

The Risk of Remaining Status Quo



The pandemic has brought about new challenges in the way we live, work, and play. The entertainment industry has been hit immensely hard, and the gambling and casino industry is no different.

With the effects of COVID remaining fresh in the minds of people as they return to work, it creates risks to the industry that have not been seen at this scale before. Financial and other pressures, require the agency to increase monitoring of transactions, review conflicts of interests, and ensure proper segregation of duties.

Without an increased budget to fill vacant position and hire additional staff the New Mexico Gaming Control Board faces many challenges with enforcing gaming and bingo laws as required by the New Mexico Gaming Control Act, and the New Mexico Bingo and Raffle Act.

Thus, making it especially difficult to expand our vision for the agency to tackle the rapid growing problem of illegal gaming in the state.
