Thirteenth Judicial District Court

- •133 FTEs including:
 - 8 District Court Judges
 - 8 Magistrate Court Judges
 - 117 employees
- Eight courthouses in five cities:
 - Cuba, Bernalillo (2), Grants (2), Los Lunas (2), and Belen







Structural challenges

- Growing population
 - District Population: 250,111 (Census Bureau 2019 pop. est.)
 - Second most populous judicial district
 - Population grew 6.3% from 2010 to 2019
- Geographically large
 - Land area of the district is the size of New Hampshire
- •High Judge and staff need:
 - 3.5 more district court judges needed
 - 18.73 additional judicial specialists needed

Fiscal Challenges

- •2020 special session cut the Thirteenth's budget 104.3 *below* FY20 funding levels.
- Sandoval County cut Pretrial Funding 50% from 100.0 to 50.0 in FY21
- Funding for pay raise for staff earning less than \$50,000/yr short 10.1
- •Foreclosure Settlement Program grant ended, resulting in loss of 130.6. Was partially replaced by GF, but eliminated in special session.
- •In all, FY21 funding is 295.0 below FY20 funding levels
- •To meet the FY21 challenges the Thirteenth has:
 - A current vacancy rate of 7.7%
 - Reduced IT spending by 1/3rd
 - Eliminated our small travel budget

Effect of Further Reductions

- •A 5% reduction in FY22 funding (which totals 826.2 below FY20) would lead to:
 - High vacancy rate of 10.1% (600.2 savings)
 - 30% reduction in treatment court participants (136.8 savings)
 - Use mediation funds to cover salaries and benefits (89.2 savings)
 - Results in the loss of 1,621 mediation hours, requiring district judges to hold more hearings when the District needs 3.5 more district court judges
- •A flat budget compared to FY21 (which is 295.0 below FY20) would mean:
 - An elevated 6.2% vacancy rate (226.3 savings)
 - Use some mediation funds for PSEB (68.7)
 - Results in 1,249 lost mediation hours



FY22 Request

Our GF request would return the Thirteenth to funding provided by the 2020 regular session. It would provide:

- •127.1 to fill vacant judicial specialist positions
- •131.4 to replace expiring Pretrial Services grant that funds two pretrial services officers in Sandoval County
- •50.0 to replace expiring DOH grant funding for case management in adult drug court

Our special request would provide 155.7 to fund the Foreclosure Settlement Program through FY22.

- FSP brings lenders and homeowners together early in the court case to examine all settlement options.
- •FSP settled 74% of cases in FY20. Of the settlements, 69% resulted in the homeowner keeping the home.
- •We anticipate a steep increase in foreclosures starting in January 2021
