



RECOMMENDED CAPITAL OUTLAY FUNDING

The New Mexico Higher Education Department (NMHED) has recommended capital outlay funding for Navajo Technical University (NTU) as part of the 2024-26 funding cycle. These recommendations reflect NTU's commitment to campus security, academic growth and infrastructure renewal. Proposed funding requests are listed below:

Infrastructure Improvement

- NTU Pedestrian Safety Improvements
 - o Purpose: To plan, design, construct, and equip pedestrian safety improvements at the main campus in McKinley County.
 - Synopsis: Funding to enhance pedestrian safety through comprehensive campus improvements, reducing risks for students, staff, and visitors.

Supplemental Funding

- NTU Academic Building Supplemental
 - o Purpose: To plan, design, construct, furnish, and equip new academic building at the main campus in McKinley County.
 - Synopsis: Additional funding to support building completion to meet growing educational needs in an enhanced learning environment.

Demolition

- NTU Student Services Building Demolition
 - Purpose: To plan, design, abate, and demolish the Student Services building at main campus in McKinley County.
 - Synopsis: Funds for removal of an outdated and potentially unsafe building to allow for future campus development.
