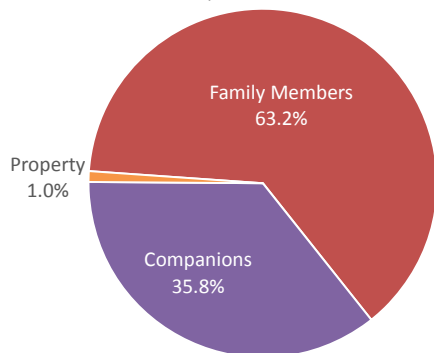

2012: Roles of Companion Animals in U.S. Households



- ❖ Record number of U.S. homes with at least one companion animal: 56-68%
- ❖ Those animals are now considered part of the family by a large majority of people in the U.S.

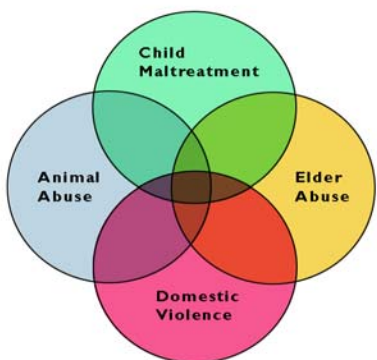

**FBI to start tracking animal cruelty in 2016**

BALTIMORE — The FBI will begin tracking cases of animal cruelty nationally in 2016, a move advocates hope will bring more attention to the crime among law enforcement agencies and underscore the link between animal abuse and other violent crimes.

Until now, animal-related crimes have been reported into a catch-all category in the FBI's National Incident Based Reporting System. The database collects crime reports from police departments across the country.

"There was no way to find out how often it occurs, where it occurs, and whether it was on the increase," said Mary Lou Randour, senior adviser for animal cruelty programs and training at the nonprofit Animal Welfare Institute. "Empirical data is important. It's going to give us information about animal cruelty crime so we can plan better about intervention and prevention."

Randour and others say tracking animal cruelty cases is especially important because research has shown that violence against animals can be an early indicator that a person will be violent toward humans, and that animal abuse often occurs alongside other crimes such as domestic violence.


"In animal abuse, you have total power over the animal," said Baltimore County prosecutor Adam Lippe, who handles cruelty cases. "If you're willing to exert that in a cruel, malicious and vicious way, then you're likely to do that to people too, who don't have power, like children and vulnerable adults. It's an issue of a lack of empathy."

The National Link Coalition, which promotes understanding of the connection between animal abuse and other crimes, says witnessing animal abuse and neglect can desensitize a child to violence and impede the development of empathy.

Randour, who advocated for the FBI change for years, says a spouse may use violence and threats against pets as part of a pattern of abuse.

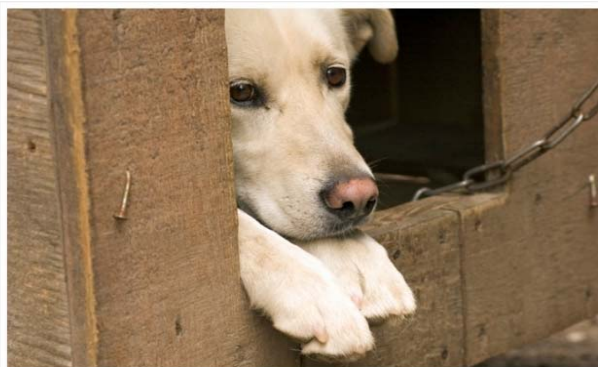

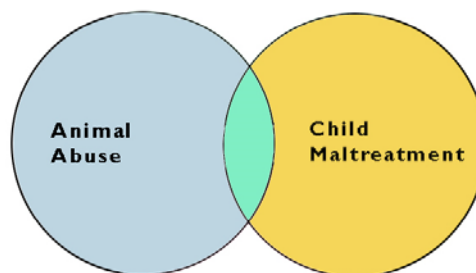
- ❖ 76% of animal abusers also abuse another family member
- ❖ Animal Abuse alone is a serious crime... but, it can also be an indicator of other violence in the family

## The Link to Child Abuse

- HSUS study (2001): 1,677 reports of intentional cruelty to animals had 67% co-existing child abuse
- A Canadian national survey found that 2/3 of homes that reported child abuse also reported instances of animal cruelty





## The Link to Child Abuse

### ❖ Cruelty to Animals in 6-12 Year Old Children

- More frequent among children who experienced **violence and abuse**
- **Sexual + physical abuse** increases animal cruelty in boys
- **Sexual abuse + domestic violence** exposure increases animal cruelty among girls

ALBUQUERQUE, N.M. — A man accused by Las Cruces police of slamming a puppy so hard its leg had to be cut off is now accused of causing multiple injuries to his 7-month-old son, including leaving a shoeprint-shaped bruise on the child's chest.

According to a criminal complaint filed Saturday in Bernalillo County Metropolitan Court against Cody Carmack, 24, paramedics rushed the child from his Albuquerque home to the University of New Mexico

Carmack was arrested in August 2011 on a charge of extreme cruelty to animals. According to police, during an argument with his roommate on July 23, 2011, he kicked the puppy before picking it up and slamming it against a metal bed frame.

The dog, a 5-month-old wirehair terrier, suffered a broken tibia and fibula. A few days later, after the roommate moved to a new apartment, a neighbor noticed the puppy was dragging its right rear leg and took it to a veterinarian's office where the dog underwent surgery.

In an appearance Sunday in Metropolitan Court, Carmack's bond was set at \$50,000 cash or surety.

Online court records show that the Las Cruces animal abuse case was dismissed by Judge Fernando Macias in June 2013.

Carmack's criminal history also includes a July 2013 conviction on a delivery or manufacture of drug paraphernalia charge. He was charged with assault and battery against a household member and interference with communications in June 2014 in Metropolitan Court, but the case was dismissed,

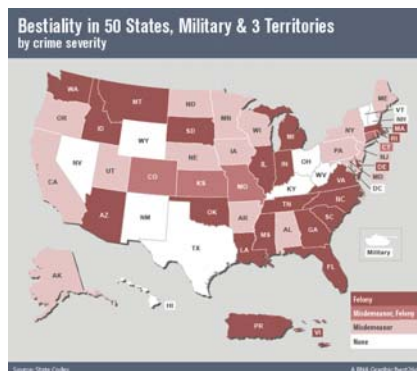

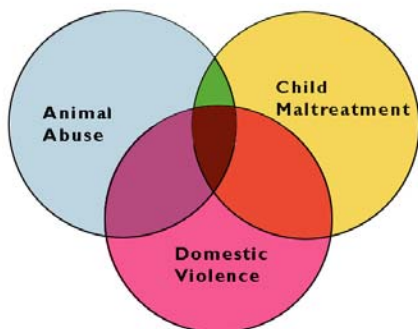
## Child Abuse – What Can We Do?

### ❖ Therapy Options for Animal Abusers

- Usually means empathy has been lost
  - ✓ Sources: Abuse, trauma, learned behavior
- Re-teaching empathy becomes the purpose for therapy
  - ✓ Also important to children who witness, not participate in, animal abuse



## The Link to Domestic Violence



**“Batterers who also abuse their pets are both **more controlling** and use **more dangerous forms of violence** than batterers who do not.”**

## The Link to Domestic Violence

- ❖ In domestic violence situations, harming animals:
  - perpetuates context of terror
  - demonstrates power
  - warns "you may be next"
  - eliminates source of support or comfort
  - provides incentive for woman to stay
  - reinforces that there is no safe place



## The Link to Domestic Violence

### ❖ Lethality Assessment

- 3 top indicators that a woman will be killed by her batterer
  - ✓ Homicide or suicide gestures / threats
  - ✓ Access to weapons
  - ✓ Threat to mutilate or kill companion animals

### ❖ Yet, people don't leave DV situations out of fear for their animals

- 1 in 3 won't leave because they can't take animals with them
- 25% return to abuser because of concern for their animals

## Domestic Violence – What Can We Do?

### ❖ Companion Animal Rescue Effort (CARE)

- NM legislature set aside funds to provide short-term housing for companion animals in domestic violence situations.
- NMCADV and APNM
- Since July 2014, 129 animals have received assistance!

### ❖ On-Site Sheltering of Animals at DV Shelters

- Positive Links currently working with 2 shelters to open their doors to entire families, including companion animals
- Working with others in the community to provide needed supplies
- Funding for inside and/or outside accommodations





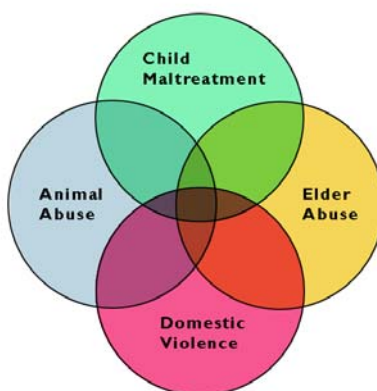
## Domestic Violence – What Can We Do?

### ❖ Protective Orders

- Some states allow companion animals in protective orders
  - ✓ NM law does not mention animals in the authorizing statutes
    - Efforts to explicitly allow animals in protective orders have failed numerous times

## The Link to Elder Abuse

- ❖ Elders benefit greatly from companion animals:
  - Increase levels of activity
  - Provide companionship and support
  - Ease loss in natural disasters, bereavement
  - When moving to residential care, there are significant benefits when elderly persons keep their companion animal(s)
  
- ❖ Puts the elderly and their animals at risk of
  - Coercion
  - Abuse
  
- ❖ Numerous cases of abuse of elderly person and companion animal in an attempt to gain power
  - Family members
  - Caregivers



## The Link – Policy Needs

- ❖ Animals in protective orders
- ❖ Additional funding for CARE and on-site programs
- ❖ Cross reporting allowances and/or requirements
- ❖ Inclusion of felony for animal abuse in presence of children
- ❖ Bestiality laws
- ❖ Training for more professions
