

The interpretation of a patients confidentiality under the Inspection of Public Records Act (IPRA) depends on the readers interpretation.

City of Albuquerque ruling is that it is not legally protected.



New Mexico needs to clarify how privileged patient mental health information is protected when law enforcement is involved. Thus, the proposed amendment to IPRA.

# Situation throughout the State for Mental Health Calls

- There are different levels of response:
  - Law enforcement officer with little CIT training and with possible audio recorder.
  - Law enforcement officer with CIT training and audio recorder.
  - Law enforcement officer with CIT training, audio recorder and access to separate mobile crisis response team.
  - Law enforcement office with CIT training, lapel camera,
     and access to separate mobile crisis response team.
  - Law enforcement officer with CIT training, lapel camera,
     and partnering with clinician to form mobile crisis team.

### History

- First concern was raised by a peer at a fall 2016 Mental Health Response Advisory Committee (MHRAC).
  - Reviewing SOP on use of lapel cameras when interacting with people living with a mental illness.
  - Camera's always <u>ON</u> and may be capturing private mental health information on behavioral health calls for service.
  - For everyone's safety, as much information as necessary may be given to the police by family or friends, which may include past mental health diagnosis, etc.
- Inspection of Public Records act was found to be ambiguous on whether the private mental health information is protect.
- Research of NM statutes dealing with law enforcement, mental health and confidentiality, did not clarify the issue. This situation was very unsatisfying for both the peers and families, along with law enforcement.
- With this research the Bernalillo County Forensic Intervention Consortium (BC FIC) was engaged.
- A member of the New Mexico Criminal Defense Lawyers Association offered to pen an amendment to IPRA. That is the basis for this legislation.
- Bernalillo County Legal Dept. has graciously taken the lead in facilitating meetings that lead to this initiative.

- Insert section in IPRA statute dealing with mental illness and law enforcement interactions.
- Clarify the extent of law enforcement records.
- Defining access to law enforcement records for criminal and civil cases and the protection of personal mental health information.
- Defining the protection of personal identifier information contained in public records.
