Some points before we look at NMCD prison population

- For the projection we look at total prison population.
- Total prison population includes residence population as well as any inmates who are away from the facility.
- Inmates can be away for things like transit, medical care and court.
- Overall, around 3% are away, but will return and need a bed at the facility.

Capacity by classification level

- Need to look at the number of beds by each classification level
- Extra beds may not be at the right classification

Crime Reduction Grants

FY 2022 Awards

• NMSC Grants Committee awarded \$178,000 in grants to 4 programs.

CICC	Description
2nd	2nd year continuation funding for the existing position for the Program Project Coordinator to work exclusively with the clients of the Competency Court within the Behavioral Health unit, and work closely with the Forensic Navigation Pilot Program.
4th	Start a community garden program, an exercise program, and provide for additional incentives and monitoring for participants in the Fourth Judicial District's drug and DWI court.
8th	Creation of a new problem-solving court that aims to reduce recidivism in DV defendants, improve case adjudication times, and provide therapeutic intervention as an alternative to prosecution/incarceration for DV defendants, utilizing a multi-professional treatment and counseling approach.
13th	2nd year continuation funding for monitoring of individuals in the Pre-Trial Program.





Crime Reduction Grants



8th District Program

- Looked at 911 calls, protection orders, cases files, dismissals and convictions data from 2018-2020
- Determined that given low conviction rate relative to filings and 911 calls, identifying domestic violence perpetrators promptly after an arrest and providing an opportunity for intervention after an immediate crisis was needed in their community.
- Creation of Domestic Violence Treatment Court aligned with NM Treatment Court Standards
- Was partially funded by Crime Reduction Grant
- Taos County provided additional funding

BIPs, like CAV's CHANGES, view domestic violence as learned behavior and the offender's motivation, either conscious or unconscious, to use anger and aggres-sion as tools to gain control over their victim(s). In their push for

FY 2023 Request

- Create a fund for Crime Reduction Grant Act
- Expand the fund by 882.0 thousand
- Due to the limited funds for the crime reduction grants, only small projects have been funded
- With the limited funds, most grants have supplemented existing programs
- With expanded funding, we could fund more innovative community responsive projects

NMSC Committee Work

 The Criminal Code Update Committee has formed seven working groups. The working group to assess child abuse statutes has been meeting regularly for the past few months. Working groups in the following areas will begin meeting soon: sentencing structure; mens rea; behavioral health issues as they impact the criminal justice system; race and ethnicity data; homicide statutes; and criminal sexual penetration statutes.
