LEGISLATIVE COMMITTEE WITH INSPECTION RESPONSIBILITIES

- Legislative committees that have an active oversight role which goes beyond the passage of legislation affecting correctional agencies and the review of population management issues. Legislative committees that focus on conditions in correctional facilities and the treatment of prisoners.
- Kansas Joint Legislative Committee on Corrections and Juvenile Justice Oversight
- Ohio Correctional Institutions Inspection Committee



KANSAS JOINT LEGISLATIVE COMMITTEE ON CORRECTIONS AND JUVENILE JUSTICE OVERSIGHT

Members

- Seven members from each chamber.
- House members must include members of appropriations and judiciary committees.

Duties

- Monitor the inmate population and review programs, activities and plans of the DOC for duties prescribed by statute.
- Review and study adult correctional programs and activities, and local government facilities, including jails and facilities run by private entities.
- Make an annual report to the legislative coordinating council and special reports to other legislative committees as deemed appropriate.





From the Ohio CIIC website:

- CIIC serves legislators.
 - CIIC provides objective, nonpartisan information for confidential legislator requests.
 - CIIC conducts unannounced inspections of all state correctional facilities for an unvarnished view of current conditions in Ohio.
 - CIIC published over 70 reports in the last biennium and is on track to publish a similar number this biennium, providing necessary information to decision-making legislators.
 - CIIC responds promptly to legislative offices that receive prison-related questions from district voters.
 - CIIC analyzes thousands of staff and inmate contacts, keeping its finger on the pulse of current issues in Ohio prisons.

Ohio Correctional Institution Inspection Committee

Annual evaluations of state prison facilities, reported to legislature.



The ratings are based on a four point scale and are based on the balance of the indicator ratings for that area.

- A rating of "Exceptional" for an indicator means that there is no room for improvement and, generally, that the facility performs above other prisons.
- A rating of "Good" for an indicator means that the prison more than meets the standard, but is not significantly better than other prisons or there is still room for improvement.
- A rating of "Acceptable" for an indicator means that the prison just meets the standard or meets the standard with minor exceptions.
- A rating of "In Need of Improvement" for an indicator means that the prison does not meet standards, is significantly different from other prisons in a negative manner, or that CIIC staff had serious concerns.

GENERAL GOVERNMENT AUDITING BODY

Agency in state government which conducts reviews of wide variety of state agencies, not just corrections.

Florida Office of Program Policy Analysis and Governmental Accountability (OPPAGA)

- Research arm of state legislature.
- Conducts research as directed by state law, the presiding officers, or the Joint Legislative Auditing Committee.

Utah Legislative Auditor General

- Constitutionally established.
- Statutorily required to "conduct comprehensive and special purpose audits, examinations, and reviews of any entity that receives public funds..." Utah Code § 36-12-15.

GOVERNMENTAL AGENCY OR COMMISSION

Entity external to the DOC with statutory responsibility for oversight of prisons. Authority to report on prison conditions and some may be able to sanction institutions.



GOVERNMENTAL AGENCY OR COMMISSION

Connecticut Criminal Justice Policy Advisory Commission

- Established in statute.
- Duties:
 - Develop and recommend policies for preventing prison and jail overcrowding.
 - Identify specific needs for reentry services in geographic areas throughout the state.
 - Identify institution-based and community-based programs and services that effectively address offender needs and reduce recidivism

Georgia Board of Corrections

- Established in statute.
- 19 members, one from each congressional district and 5 at-large.
- "The Board of Corrections is a policy-making statutory board and has legal status only as a board. The operations and management of the GDC institutions, and facilities are the responsibility of the Commissioner."



GOVERNMENTAL AGENCY OR COMMISSION

Tennessee Corrections Institute

- Established in statute.
- Must establish minimum standards for correctional facilities.
- Conducts inspections.
- Educates correctional staff.





INSPECTOR GENERAL

Investigates criminal wrongdoing and serious misconduct in an agency.



Nebraska created OIG in 2015

- Annual reports to legislature.
- Two issues identified in last report are understaffing and overcrowding.

What We Do

California OIG

Employee Discipline Monitoring

 Evaluate the department's investigations conducted by its Office of Internal Affairs and assess the legal advice provided by departmental attorneys throughout the disciplinary process.

Critical Incident Monitoring

Respond on-site 24 hours per day to critical incidents, such as large-scale riots, uses of deadly
force, and unexpected inmate deaths at any of the State's 35 correctional institutions and to similar
incidents in the community involving correctional staff.

Staff Complaint and Inmate Grievance Monitoring

 Monitor the department's handling of inmate grievances and complaints concerning alleged staff misconduct.

Blueprint Monitoring

Review reforms the department identified in studies it conducted over the past decade.

Use-of-Force Monitoring

· Monitor the department's review process for use-of-force incidents.

Medical Inspections

 Evaluate the quality of medical care at adult institutions using a unique combination of quantitative and qualitative data analysis methods.

Audits and Authorized Special Reviews

 Review departmental operations, policies, and procedures by self-initiated audits or by special reviews when requested by the Governor, the Assembly, or the Senate.

Complaint Hotline and Intake

 Maintain a statewide complaint intake process to address concerns from any individual regarding allegations of improper activity within the department.

Retaliation Complaint Reviews

Review complaints of retaliation that departmental staff level against members of their management.

Ombudsperson for Sexual Abuse Complaints

 Serve as the ombudsperson for complaints related to the Sexual Abuse in Detention Elimination Act (SADEA), also referred to as the Prison Rape Elimination Act (PREA); review allegations of mishandled sexual abuse investigations within correctional institutions.

Chair of the California Rehabilitation Oversight Board

Chair the board that provides public oversight of the department's rehabilitative programs.

Warden and Superintendent Vettings

Conduct background and qualification reviews of warden and superintendent candidates.

OMBUDSPERSON

An ombudsperson is responsible for investigating complaints about misconduct or conditions in corrections departments.

Alaska Office of Ombudsman

Corrections

- Inmate Health Access to treatment, medication for chronic disease (J2008-0161)
- Inmate Health Access to medication (A2010-0601)
- Institutions Seizure of prisoner property (A2007-0557)
- Institutions Drug testing policy (A2007-1411)
- Institutions Management of inmate funds (A2013-0210)

Michigan Legislative Corrections Ombudsman

- Recommendations to DOC and legislature.
- Must exhaust all administrative remedies prior to investigation of complaints.
- Investigates complaints that allege a violation of MDOC policy or state law.



ADVOCACY GROUP WITH FORMAL RIGHT OF ACCESS

Non-governmental but have a mandate, legislative authorization, or routine agency permission to provide some form of oversight of correctional facilities.

John Howard Association (Illinois)

- Independent, non-profit, non-partisan.
- Visit approximately 20 facilities.
- Focus on medical/mental health care, disciplinary procedures, physical condition of facilities and programming.

Pennsylvania Prison Society

- Defined as "official visitor" in statute.
- May visit any day between 9 am and 5 pm and interview incarcerated people in their cells or private interview rooms.
