# **CRIMINAL JUSTICE REFORM BILLS, 2015 SESSION**

The Criminal Justice Reform Subcommittee (CJRS) was created in 2013. It endorsed 10 bills at the end of the 2014 interim for the 2015 regular session. Five CJRS-endorsed bills were also endorsed by the Courts, Corrections and Justice Committee (CCJ) in 2014; see bills with \* below.

The CJRS-endorsed bills that were not endorsed by the CCJ were:

-.198151.2, SJM 4 (Rue), Services for Mentally Ill & Awaiting Trial. Passed S 40-0, H 59-0. Signed.

-.198200.1, HB 85 (Alcon), Commercial Code & Voidable Transactions. Passed H 64-0, S 39-0. Signed and chaptered, Ch. 54.
