MISSION

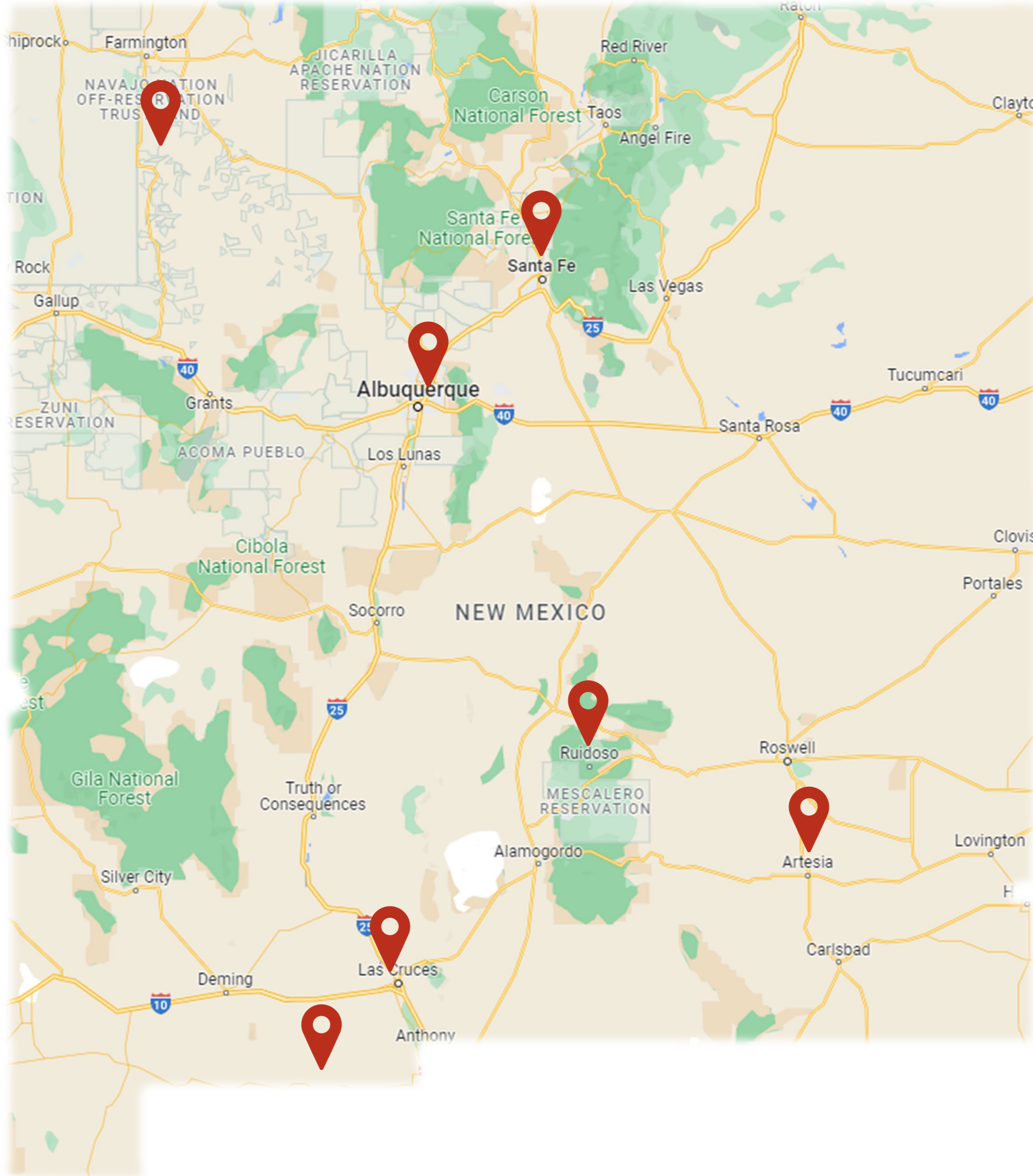
