The Cannabis Control Division's mission is to ensure the health and safety of all New Mexicans by responsibly licensing and regulating all commercial cannabis operations in the State of New Mexico. The division administers a regulatory structure that encourages a robust, responsible, and legitimate cannabis market while preserving safe consumer access to cannabis by implementing strong enforcement measures to prevent illicit and unsafe cannabis activity.

- Adult-Use Sales: \$501,863,156.00
- Total Sales: \$772,194,801.63

### Legislative Ideas

- I. Amend NMSA 1978, 26-2C-7(J), "Commercial cannabis activity licensing; application; issuance and denial of a license," to require biometric criminal history reports, which would allow the Division to conduct federal criminal background checks.
- II. Amend NMSA 1978, 26-2C-40, "Plant Limit," to eliminate the revocation of plant count limits, which is set to expire December 31, 2025.
- III. Amend NMSA 1978, 26-2C-6(I), "Licensing cannabis activities; limitations; medical cannabis legacy licensing; cannabis shortage for medical program" to allow persons licensed pursuant to the Liquor Control Act to also be licensed pursuant to the Cannabis Regulation Act, provided that commercial liquor activities and commercial cannabis activities to not occur on the same licensed premise.
- IV. Amend NMSA 1978, 26-2C-2(GG), "Definitions" to clarify that integrated cannabis microbusinesses may retail products produced or manufactured from other integrated micro and micro producer cannabis licensees.
- V. Add authority for the CCD to order the seizure and destruction of unlawfully possessed cannabis and cannabis products and authorize the Department of Public Safety to carry out or oversee the seizure and destruction activities.
