- Established by the passage of HB 232 in the 2024 regular session as of July 1, 2024
- Essential functions outlined in the legislation include:
 - Providing technical assistance to political subdivision of the state
 - Receive and review Infrastructure Capital Improvement Plans (ICIPs)
 - Leverage state dollars for the acquisition of federal funds

This division will work closely with all state executive agencies, the legislative branch, the judicial branch and local public bodies to provide planning and funding assistance for all capital projects listed on the Infrastructure Capital Improvements Plan (ICIP). The mission is for this division to successfully manage the planning of all capital outlay projects and to assist all entities with fully funding all capital outlay projects appropriated through Federal Bills, the Capital Appropriation Bill, the Reauthorization Bill, the GOB Bill, the HB2 Specials related to capital and any Junior Bill.

Policy Bureau

- The bureau will assist state agencies and local governing bodies with planning their capital projects.
- Collaborate with the development of the ICIP, the review of the ICIP, as well as direct them to other resources for fully funding their capital outlay requests.
- Work closely with executive agencies and the Governor to prepare the Executive Capital Budget.
- Assist with the general fund questionnaire process and work with the State Budget Division to assure all appropriations are budgeted and available for grant administration.
- Monitor the Capital Projects Management System (CPMS) and work with local governments and state agencies to assist with reporting.
- Also responsible for creating and updating policy for the Division.



Capital Navigation and Funding





Assistance Bureau



- The bureau will be responsible for assisting state agencies and local governing bodies with finding funding for their capital projects.
- Responsible for coordinating the funding opportunities and providing guidance with applying for capital grants.
- Update and oversee the maintenance of the Catalog of Local Assistance.
- Collect data and create a rural database that could inventory existing infrastructure and provide real time information for grants and stakeholders.
- Help regions organize and get funding to conduct complete comprehensive asset management plans for unincorporated rural and tribal areas.

Federal Grants Bureau







- The bureau will work directly with the Infrastructure Division to notify agencies and local governments of federal funding opportunities available.
- They will also aid with federal grant applications, including providing technical assistance or guidance with grant writing.
- Staff will assist agencies with internal federal grant accounting, auditing, and monitoring issues that may hold an agency back from receiving federal funds.

Looking Forward





Future Mission of the Division:

This division will work closely with all state executive agencies, the legislative branch, the judicial branch, and local public bodies to ensure all capital projects are successfully completed from inception to completion. The mission is for this division to successfully manage the planning, budgeting, grants administration, project management, fiscal management, reporting and closeout of all capital outlay projects appropriated through Federal Bills, the Capital Appropriation Bill, the Reauthorization Bill, the GOB Bill, the HB2 Specials related to capital and any Junior Bill.





State and Local Governments Own Vast Majority of Public Capital


Value of public non-defense buildings and other structures, 2017







Encouraging Capital Stacks

In what order do we prioritize infrastructure development vs economic development?







- Need infrastructure improvements that can pay off economically in private-sector investment and productivity growth
- Infrastructure improvements spur economic activity by creating jobs and stimulating development



The New Mexico Match Fund

The New Mexico Match Fund was established in the 2024 Regular Session with an initial appropriation of \$75 million.

\$62.5 million for Matching Grants:

For every \$1 in matching grants awarded, \$4.26 is returning to New Mexico in federal funds

\$7.5 million for Project Implementation Grants:

Will support a combined \$150 million in federal and matching grants with project administration and completion

\$3 million for Federal Compliance Offset Grants:

• Awarded to Village of Los Lunas for cost increases associated with Buy America requirements imposed on I-40 interchange project

- Production Tax Credit for Electricity from Renewables (§ 45, Pre-2025)
- Clean Electricity Production Tax Credit (§ 45Y, 2025 onwards)

 Credit for Qualified Commercial Clean Vehicles (§45W)

Site Selection and Site Readiness







Site selection includes analysis of the factors that determine the optimal location for each project, including access to infrastructure

How IPDD Support Site Readiness:

- Funding navigation to support site development projects by local public bodies
- Access to the NM Match Fund for federally funded site readiness projects
- Rural and Frontier Equity Ombudsman
- Future efforts related to GIS mapping and layering existing maps of infrastructure assets that will be a tool to identify site readiness
