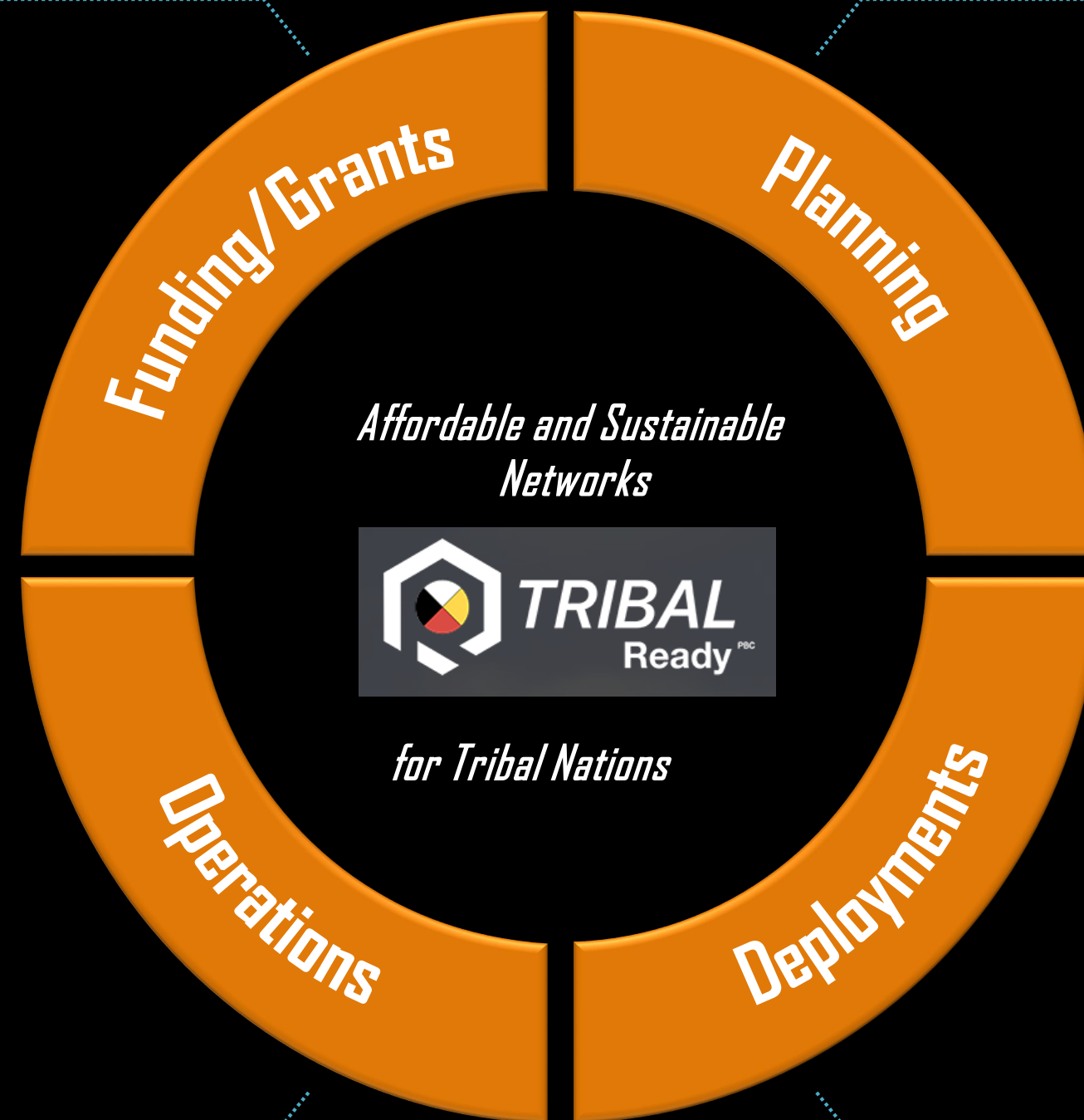

For Tribal Nations, gaining control over broadband infrastructure is not just about closing the digital divide in tribal communities; it is about defending sovereignty and ensuring self-determination in the digital age.

## PARTNERSHIPS

## CAPACITY BUILDING

Training and hiring Tribal Data Managers and Analysts to oversee and protect data. Empowers Tribes to manage their own data systems without reliance on outside parties.



## BUILDING TRUST

Maintaining strong, transparent relationships with State and Federal agencies. Ensures data is shared only in ways that align with Tribal Sovereignty and protects Tribal interests.

## BUILDING TRIBAL DATA INFRASTRUCTURE

Developing internal servers and data systems to maintain control over Tribal data. Ensures that data is stored and managed within the Tribe's infrastructure, providing security and autonomy.

## DATA GOVERNANCE POLICIES

Establishing guidelines for data collection, storage, and usage to protect Tribal rights. Guarantees that data usage aligns with Tribal laws and values, preventing misuse.
