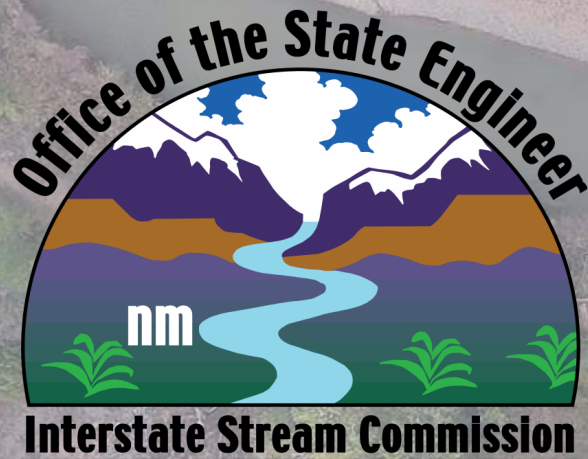

Steps to Reaching a Final Settlement Agreement



- Federal Assessment Team
- Federal Negotiation Team
- Negotiations with Pueblo/Tribe/Nation, United States and State
- Negotiations expanded to include local entities, acequias, irrigation districts, municipalities, cities, etc.
- Local Settlement Agreement signed by all Parties but for United States
- Parties draft Federal Legislation
- Review by Working Group and SIWRO
- Federal Legislation - introduced in House and Senate; Congressional Hearings
- Once passed by Congress - parties conform the Settlement Agreement
- Approval and signing of conformed Settlement Agreement by DOI
- Regular court adjudication process for entry of a Partial Final Judgment and Decree adjudicating the water rights within a stream system/basin and accepting the Settlement Agreement (includes inter se)
- State funding process - Indian Water Rights Settlement Fund



Overview of Water Rights Settlements with Pueblos, Tribes, and Nations

7 Pueblos, Tribes, and Nations have reached final settlements with Congressional, State, and Judicial Approval:

- Jicarilla Apache Water Rights Settlement
- Taos/Abeyta Settlement Agreement
- Navajo San Juan Settlement Agreement
- Aamodt Settlement Agreement (Nambé, Pojoaque, Tesuque, San Ildefonso Pueblos)

One Tribal Water Right Claim Was Litigated to Final Judgment:

- Mescalero Apache Tribe (Rio Hondo/Pecos River Stream System)

Recent Settlements During the Lujan Grisham Administration

Local settlement agreements have been signed and federal legislation has been introduced.

- **Rio San José Stream System**
 - Acoma Pueblo
 - Laguna Pueblo
 - Navajo Nation
- **Jemez River Stream System**
 - Zia Pueblo
 - Jemez Pueblo
- **Rio Chama Stream System** (Ohkay Owingeh)
- **Zuni River Stream System** (Zuni Pueblo)

Rio San José Settlements

Parties: Acoma Pueblo, Laguna Pueblo, Navajo Nation, State of New Mexico, City of Grants, Village of Milan, nine individual acequias and community ditches, Association of Community Ditches of the Rio San José.

Federal funding:

- **\$850 million** (indexed) for Pueblos for alternative water supply infrastructure, operation and maintenance of alternative water supply project, Acomita Reservoir dam safety, and feasibility studies.
- **\$245 million** (indexed) for Navajo Nation for water infrastructure.

State funding:

- **\$39 million** (indexed) total
 - \$250,000 in early funding for needs assessment for acequias
 - \$15 million for water projects for acequias
 - \$500,000 mitigation fund
 - \$23.5 million for Grants and Milan for cost share for water projects

Rio Jemez Settlement

Parties: Jemez Pueblo, Zia Pueblo, State of New Mexico, Jemez River Basin Water Users Coalition, City of Rio Rancho.

Federal funding:

- **\$490 million** (indexed) for a mutual benefit water supply project and other infrastructure and costs.

State funding:

- **\$20 million** (indexed) total
 - \$3.4 million for capital and operating expenses for the San Ysidro Community Ditch Association
 - \$16.2 million for acequia ditch improvements for member acequias of the Jemez River Basin Water Users Coalition.
 - \$500,000 mitigation fund

Ohkay Owingeh Rio Chama Settlement

Parties: Ohkay Owingeh, State of New Mexico, City of Española, approximately 80 acequias from the Asociación de Acéquias Norteñas de Rio Arriba (“Acéquias Norteñas”), Rio de Chama Acéquia Association (“RCAA”), la Asociación de las Acéquias del Rio Vallecitos, Tusas y Ojo Caliente, and El Rito Ditch Association.

Federal funding:

- **\$745 million** (indexed) for water projects and related purposes.

State funding:

- **\$131 million** (indexed) total, \$7 million of which is for “early funding”
 - \$11.5 million for acquisition of water storage space and water rights for RCAA
 - \$17.5 million for improvements to diversion structures for senior RCAA acequias
 - \$13.125 million for additional RCAA projects
 - \$25.875 million for Acéquias Norteñas projects
 - \$15.25 million for Vallecitos/Tusas/Ojo Caliente projects
 - \$15.25 million for El Rito projects
 - \$32 million for City of Espanola for development of additional production wells
 - \$500,000 mitigation fund

Zuni Indian Tribe Settlement

Parties: Zuni Indian Tribe, State of New Mexico

Federal funding:

- **\$685 million** (indexed) for water projects and related purposes.

State funding:

- \$750,000 for development of groundwater monitoring program and to assess impacts to Zuni Salt Lake
- \$500,000 mitigation fund

Amendments to Existing Legislation

(no state funding component)

S. 1898/H.R.3977 - Navajo-Gallup Water Supply Project Amendments Act of 2023:

This bill will increase the time allotted for completion of the project to December 1, 2029, and extend the project to reach more communities.

S.3496/H.R.659 - Technical Corrections to the Northwestern New Mexico Rural Water Projects Act, Taos Pueblo Indian Water Rights Settlement Act, and Aamodt Litigation Settlement Act:

This bill will correct an interest miscalculation by the federal government and providing federal funding for:

- Navajo Nation for the San Juan Settlement - \$6,357,674.46;
- Pueblos of Nambe, Pojoaque, Tesuque, and San Ildefonso for the Aamodt Settlement - \$4,314,709.18; and
- Taos Pueblo will receive \$7,794,297.52

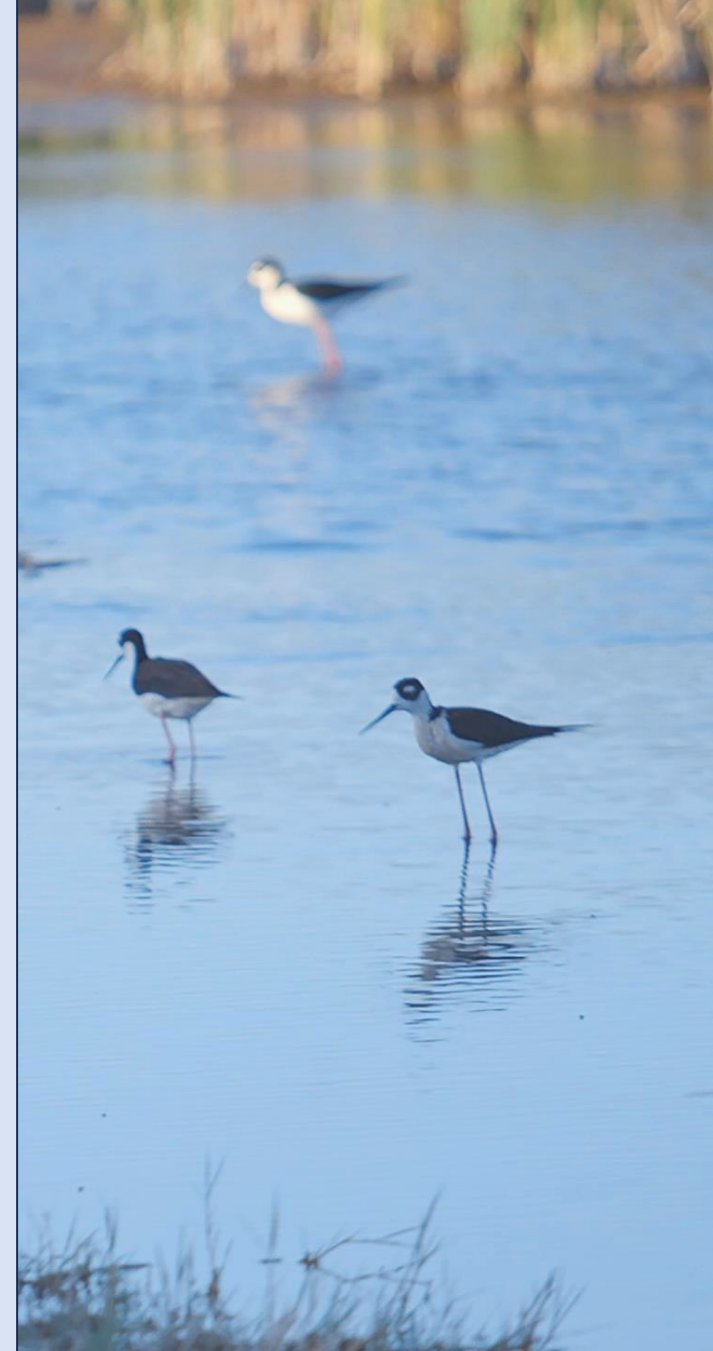

Implementing Existing Settlements

Taos/Abeyta Settlement Agreement

- Original funding for mutual benefits projects was not indexed
- The shortfall is approximately \$220 million
- With a 75/25 federal/state cost share breakdown, the state share is ~ \$43 million
- Existing appropriations would cover approximately \$10.7 million, leaving a need to fill an additional **\$32.3** million in state funding
- Parties are working with Congressional delegation to obtain needed federal funding
- Parties are engaged in securing DOI support for funding request

Aamodt Settlement Agreement

- Construction on water supply project is underway
- Reclamation has alerted parties to likely significant cost increases – **parties are working with Reclamation on review of indexing for the project to determine actual amounts**
- Updates are likely in the coming months

Navajo San Juan Settlement

- Portion of project is operational, construction on remaining portion is underway
- Parties are working with Congressional delegation to secure passage of act to make needed amendments to authorizing legislation
- OSE/ISC working with City of Gallup on additional groundwater wells to bridge supply
