



Solowork Theater

The Jobs Council has been focused on Solowork as a potential major economic base job creation program theater especially for rural communities finding it increasingly difficult to compete for traditional economic base projects. A pilot for a Solowork Job Creation Program has been developed by the CELab (501C3) in collaboration with Cibola Communities EDC, USDA, NMEDD, NWCOG, and a consortia of 5 service providers. A pilot program is organized and is expected to launch in October, 2016. The elements of this program are:

- Remote work training and placement module: A rapid recruiting, screening, training and placement program focused
 on local residents that are willing, able and qualified to pursue solowork careers that match the spectrum of jobs offered
 by the program's out of state employer partners. 90% of training graduates are placed in e-base job openings within 6
 weeks of starting the program.
- 2. **Solopreneurship module:** A Solopreneurship program focused on recruiting, starting up and converting local residents that wish to establish their own solo business, or have their own solo business that are under performing or not yet economic base in nature. This module could aslo be provided by experienced mission driven SBDC or incubator personnel.
- 3. Entry-level worker module: An entry-level worker program module is focused on recruiting, training and placing new entrants with the interest and the aptitude to be solopreneurs or do solowork. This population includes high school and higher education students, the hard to employ and the chronically poor clients of the NM Workforce Solutions-DOL systems, corrections, disconnected youth, Jobs Corps, Veterans, etc - including those who need remedial education, soft skills training and social services support to transition into the mainstream workforce.
- 4. Retention and advancement platform: A member based solowork support platform that develops a discounted suite of back office support services, concierge services, co-working space, tax and regulatory advocacy and socialization services and performance reporting on each program module. This module is crucial to improving productivity and reducing the social isolation that drives the high rate of attrition among solo workers.

Initial program assessments estimate that minimum job creation potential using the following heuristic.

Population	Workforce Size	Workers suited for solowork	Served by program (.2% of pop)
10,000	4,000	400	200

In summary, for every 10,000 residents in the population, 200 could be placed in a solowork position by the program over 10 years. A post-performance cost for a SoloWork Center to create and support each job ranges from \$3,500 to \$5,000.
