## PROJECT DETAILS

---

9. Project abstract **The Land Grant-Merced Regional Outdoor Recreation Project is a collaboration of seven land grants (the Tajique, Chililí, Manzano, Town of Tomé, Torreón, Cañón de Carnué and San Antonio de las Huertas Land Grants) located around the Manzano and Sandia Mountains that seek to collectively create a land grant-merced youth conservation crew to work on several projects in seven land grants across four counties. The projects include trail creation and improvement (including trail improvements around a fishing lake, recreation and camping area, and community playground), creating and improving community parks and playgrounds, and building erosion controls at community centers and playgrounds and at a popular spiritual and pilgrimage site. Through partnership and collaboration with Ancestral Lands (nonprofit focused on developing indigenous youth conservation corps), the UNM Land Grant Studies Program, the NM Land Grant Council (state agency tasked with supporting land grants), and the Resource Center for Raza Planning at the UNM School of Architecture and Planning, we are confident that we can make significant improvements in each community increasing recreation opportunities and improving physical health. Outdoor recreation has always been an affordable way for people to benefit from fresh air and activity. The communities participating in this regional project are underserved populations with limited access to safe and functional recreation opportunities. Working collectively, each community will use the resources they have to make substantial improvements to their public spaces, providing them the opportunity to strengthen community and improve spaces where people can safely engage in outdoor recreation.**

10. Full project description **The Land Grant-Merced Regional Outdoor Recreation Project will employ a youth conservation crew to work on outdoor recreation projects in the Tajique, Chililí, Manzano, Town of Tomé, Torreón, Cañón de Carnué and San Antonio de las Huertas Land Grants in Tarrant, Valencia, Bernalillo and Sandoval Counties. By partnering with Ancestral Lands (ALCC), the youth will receive the proper training and certification to complete these projects. Specific land grant by land grant project information is below. The Tajique Land Grant has a newly established park at the Tajique Land Grant**

Community Center, but poor planning has left the community with a park prone to flooding which is causing damage to the playground and outdoor basketball court. A swale is needed to re-establish the natural water flow in order to divert water away from recreation areas, including the community center itself, which has been flooded several times, forcing the removal of the floor. This erosion and diversion work will be done by digging the swale and creating dams and barriers by placing river rock and divots to slow down the flow of water and channel it away from the park and playground. This will create a safe place for kids to play free of flooding and tripping hazards created by erosion. The Tajique Land Grant Community Center is a popular outdoor recreation site for the entire community's youth and hosts youth programs for the entire community. The Chililí Land Grant has a community gym with an outdoor park and playground that is only accessible by local youth on foot by walking along State Highway 337, which does not have a shoulder or sidewalks. The Chililí Community Center hosts community celebrations, meetings, and other events and the outdoor park, including an outdoor basketball court and playground, are often used in conjunction with the center. Creating a trail to the recreation site, on land grant common land away from the highway, will significantly decrease the danger of walking to the park and will increase the park's use. This will be done by trimming back trees and other vegetation and digging in tread to establish a trail. The Chililí Land Grant believes that this will increase the safe use of its outdoor community park. The Manzano Land Grant has a five-acre lake that is a very popular regional destination for fishing and walking. It is the only lake in the East Mountains and is stocked by the New Mexico Department of Game and Fish. Unfortunately, the lake has become overgrown with invasive trees and shrubs. This overgrowth has taken over the walking path and has reduced the areas available for those who want to sit and fish. This project requires trimming the brush, removing noxious trees and shrubs as well as improving and realigning the walking path around the lake. This will allow for a safer area for those who exercise by walking around the lake. It will also provide sufficient space for those who visit the lake to fish by widening the trail to allow space for them to sit or stand and fish. The Tomé Hill Park has a paved walking path at the bottom of the Tomé Hill, a regional and national pilgrimage site. The pathway is surrounded by sandy hills and the rain and runoff from these hills has caused the pathway to be with inundated with sand and gravel. There are also some native shrubs and weeds that have grown onto or are encroaching into the path. Many people walk to the top of the Tomé Hill, for both physical and spiritual health, however for those who cannot make the (452 ft elevation gain) hike, the pathway is a safer alternative for elderly and disabled still wishing to recreate and worship adjacent to Tomé Hill. This project will require hand thinning and removal of brush and creating check dams and barriers to prevent further erosion and silting runoff onto the existing paved trail. In Carnuel, the Cañón de Carnué Land Grant looks to expand a campground below their land grant hall so that heirs and members can enjoy the outdoors on the land grant common lands. The campground was built four years ago and has steadily been

improved with benches and firepits. Expanding and improving the campsite might involve building picnic tables (from kits), clearing land for campsites, building firepits and building and/or improving trails. This area is near the site of a former gravel pit that the land grant is gradually remediating and near an ongoing riparian restoration project on the spring-fed creek. In Torreón, the community playground provides a family community space, one of the few in this small mountain community. Located near the Torreón Community Center and volunteer fire department, the community playground is centrally located in the community. The playground is in need of maintenance, particularly the replacement of the current fill with wood mulch or a similar affordable alternative fill. Over the past several years, the San Antonio de las Huertas Land Grant has built El Campo del Oso Recreation Area. El Campo del Oso features picnic tables, firepits, picnic canopies, camp decks, open area camping, tents, an RV area, an outdoor kitchen and toilets. It has become a popular place for community gatherings and is an important economic generator for our land grant and is advertised and booked on Hipcamp. The youth conservation crew will build trails around the recreation area and build berms to hold back water to prevent erosion and flooding. The Land Grant-Merced Regional Outdoor Recreation Project is requesting \$25,000.00 for 4 weeks of work by an ALCC youth crew (\$20,000.00) and \$5,000.00 for materials for the seven sub-projects. The project will be matched with approximately \$56,000 in cash and inkind. This will include a \$25,000 cash match by the New Mexico Land Grant Council, \$2,000.00 in cash and \$6,666.66 inkind by the ALCC and cash and inkind contributions from each of the seven land grants-mercedes participating in the project, including \$9,875 from the Tajique Land Grant, which includes capital dollars.

**The Tajique Land Grant project will take place at the Tajique Community Center (8636 Highway 55, Tajique, Torrance County, NM 87016,) and will benefit the community of Tajique and surrounding communities; the Chililí Land Grant project will take place at the Chililí Community Center's park and playground (9868 Highway 337, Chililí, Bernalillo County, NM 87059) and will benefit Chililí, Escabosa, Yrisarri, and surrounding communities; the Manzano Land Grant project will take place at Manzano Lake (Pinos Reales Road, Manzano, Torrance County, NM, 87061) and will benefit Manzano, Punta de Agua, and the entire East Mountains region; the Town of Tomé Land Grant project will take place at the Tomé Hill Park, 442-448 La Entrada Rd, Los Lunas, Valencia County, NM 87031) and will benefit Tomé, Jarales, Adelino, Los Lunas, the entire Río Abajo region; the Torreón Land Grant project will take place at the Torreón Community Center's playground, 10 East Torreón Heights Road, Torreón, Torrance County, NM, 87016) and will benefit Torreón and surrounding communities; the Cañón de Carnué Land Grant project will take place on the Land Grant below the land grant hall (364 U.S. Route 66, Tijeras, Bernalillo County, NM 87059) and will benefit Carnuel, San Antonio, Tijeras and surrounding communities; and the San Antonio de las Huertas Land Grant project (Sandoval County) will take place at El Campo de Oso campground (Camino del Oso, Placitas, NM 87043) and will benefit Placitas and surrounding communities and visitors to the site.**

23. Briefly describe the need for this project. How will it improve outdoor recreation access needs in your community? Who will be the primary users or beneficiaries of this project?

**The Land Grant-Merced Regional Outdoor Recreation Project is an important regional project that provides essential upgrades to and creates new recreation sites for seven land grant communities in the Rio Abajo. Projects at the Tajique and Torreón will repair and protect playgrounds, improving access to outdoor activity for the youth of each community. This motivates not only children to exercise, but their entire family to enjoy outdoor activity. This benefits the entire community, encouraging community interaction and improving overall community health. At the Chililí, Manzano, Cañón de Carnué and San Antonio de las Huertas Land Grants, walking paths will be built or improved, to improve safe access to the community playground for Chililí, improving the path that encircles the Manzano Lake and to improve the Campo del Oso campground at San Antonio de las Huertas (Placitas) and the campground and path on the and Cañón de Carnué Land Grant, making both more appealing recreation sites. Children in Chililí will no longer need to walk along the highway. Locals and visitors to Manzano Lake can access the path for exercise and fishing. Both locals and visitors that rent the Campo del Oso campground will enjoy an improved site. The Town of Tomé Land Grant's Cerro de Tomé/Tomé Hill Park is an important access point to a regional spiritual site that people from the entire region visit for spiritual renewal and allows those unable to make the trek up the hill to continue to visit the site.**

24. How does your project enhance the region's recreation landscape? For example, will it connect to any other trail systems?

**Each of the seven communities participating in the Land Grant-Merced Regional Outdoor Recreation Project will benefit from improved community recreation facilities, from playgrounds to parks to trails. Many city dwellers are accustomed to public parks located in every neighborhood and take for granted the lack of access of community facilities in rural areas. Some rural communities have no playgrounds or parks and children can only access the playground equipment at school. Tajique, Chililí and Torreón are fortunate to have invested in these facilities years ago, but need to reinvest and upgrade these recreation facilities and improve access to them. The San Antonio de las Huertas' Campo del Oso is relatively new but growing in use and popularity and adding walking trails into the beautiful landscape will enhance the user experience for visitors from across the region. The Cañón de Carnué Land Grant seeks to improve and expand their campgrounds, creating more campsites and trails, increasing opportunities for recreation close to Albuquerque. The Manzano Lake is one of the only lakes in the region and will improve access for both fisherman and for those who visit the lake to birdwatch and exercise. The Tomé Hill Park receives visitation daily but is heavily used during Holy Week, when visitors in the thousands from across the state and region visit the spiritual site. Tomé Hill is a spiritual destination that people regularly make a pilgrimage to, exercising for their spiritual and physical health.**

What barriers or challenges might impede this project?	<b>We are confident that the Land Grant-Merced Regional Outdoor Recreation Project is a feasible project that will be completed in the time frame stated above, with physical work at project sites commencing in May 2022 and concluding by September 2022. The projects are shovel ready, were self identified by each of the seven land grant communities in the project, and involve the professional expertise through collaborations with Ancestral Lands, the UNM Land Grant Studies Program and School of Architecture and Planning's Resource Center for Raza Planning and matching financial support from both the New Mexico Land Grant Council and the Tajiique Land Grant. None of the projects are reliant on expensive materials or significant pre-work. One challenge might be recruitment of youth as the COVID pandemic has recently hampered recruitment of youth conservation crews, but with seven land grant communities participating and offering prospective youth to fill a five person crew, we feel confident that we will fill the crew without too much difficulty. Another challenge is the low operational budgets from each land grant-merced. Each land grant-merced board of trustees (who serve as volunteers) has pledged both in kind and cash support for this project. Nonetheless, without the Outdoor Recreation Trails + Grant and financial support from the New Mexico Land Grant Council, the Tajiique Land Grant, and Ancestral Lands, along with in kind support from the University of New Mexico, the project would be beyond both their financial capacity and labor capabilities.</b>

**EQUITY AND ACCESS**

**For six of the seven communities, no; the San Antonio de las Huertas Land Grant does charge a nominal fee (\$25-55 per night) to fund the upkeep and improvement of the Campo del Oso campground, which includes picnic tables, firepits, picnic canopies, camp decks, open area camping, tents, an RV area, an outdoor kitchen and toilets.**

30. How will this project support underserved members of your community?

**All seven communities participating in the Land Grant-Merced Regional Outdoor Recreation Project are underserved land grant communities. All suffer the lack of access to affordable recreation and these projects improve access to recreation within their own communities. Improving, repairing and creating safe access to parks and playgrounds in Tajique, Torreón, and Chililí will offer free access to safe outdoor play facilities for underprivileged communities, encouraging activity and positive health outcomes that will benefit the entire community. Improving trails, creating new trails and expanding campsites and camping opportunities will offer safe outdoor spaces for people to exercise and benefit the community health of Manzano, Tomé, Cañón de Carnué, Chililí and San Antonio de las Huertas. These communities all have pristine outdoor spaces that community members, included those unable to afford memberships to gyms, can enjoy more easily with improved trails. The Land Grant-Merced Regional Outdoor Recreation Project will also employ youth from the land grant communities in the project. This is an important opportunity for these youth, who hail from communities with high unemployment rates and few opportunities for young people to find work, let alone community minded, culturally affirming work that invests resources back into their communities. Participants will receive personal and professional development to help prepare them for success in and after the program, including resume building, USA Jobs training, and mentorship from agency professionals to learn more about career pathways. ALCC connects participants to career and postsecondary education opportunities**

31. Will the result of this project be ADA accessible?

**The playground equipment at the Tajique, Torreón and Chililí Land Grants is, by and large, not ADA compliant. Trails at Manzano and Town of Tomé are partially compliant and improvements will improve access, including ADA compliance and access. The trail at San Antonio de las Huertas may be built partially compliant, but will likely not meet full compliance due to the nature of the terrain and expense of building a fully compliant trail. Campground improvements and trails at the Cañón de Carnué Land Grant may be partially ADA accessible.**

32. Will this project increase outdoor recreation access for youth specifically? **Yes, the Land Grant-Merced Regional Outdoor Recreation Project will improve outdoor recreation access for youth and will involve youth in improving this access by employing local youth in a regional youth conservation crew to improve sites at all seven communities. Playground improvement and access projects will improve their safety by replacing wood mulch below playground equipment in Torreón, by improving drainage to ensure that flooding does not impede access to playgrounds in Tajique, and will improve safety and access to the playground in Chililí by building a trail away from the highway for use by local youth. Youth will enjoy increased access to fishing and walking at Manzano Lake, can enjoy an affordable camping trip with walking trails at San Antonio de las Huertas' Campo del Oso and can camp at the Merced de Cañón de Carnué campground. Finally, youth unable to make the hike up Tomé Hill can use the trail at Tomé Hill Park to enjoy the spiritual site with their families. Every project in the Land Grant-Merced Regional Outdoor Recreation Project will benefit youth and improve their access to affordable and culturally recreation in their own community.**

### ENVIRONMENTAL AND CULTURAL IMPACT

---

33. How will this project restore, enhance, or conserve the natural lands and/or waters in the region? **The Land Grant-Merced Regional Outdoor Recreation Project will restore, enhance and conserve natural landscapes and waters on several land grants. Trail building at the San Antonio de las Huertas Grant's Campo del Oso will reduce erosion and encourage visitors to not disturb flora and fauna by staying on a prescribed path. The trail improvement project at the Manzano Lake will preserve the lake's riparian area, retaining habitat for birds, amphibians and other species, reduce erosion of the path into the lake and contribute to the overall ecological health of the site. The work at Tomé Hill Park on the Town of Tomé Land Grant will mitigate erosion on the Tomé Hill, preserving the path and discouraging the thousands of visitors from climbing and causing more erosion. Creating more campsites and building and improving trails at the Cañón de Carnué Land Grant will encourage users to not disturb the flora and fauna that inhabit the natural landscape and greater riparian area that surrounds the creek. The project on the Tajique Land Grant will reduce erosion and the amount of sediment deposited to nearby waterways.**

35a. Which watershed will it protect?

The Rio Grande Watershed will benefit from these projects. The campsite and trail building project at the Cañón de Carnué Land Grant helps to protect the Tijeras Creek that runs near the campground. The San Antonio de las Huertas project at El Campo del Oso is near the the spring that feeds acequias and retaining pond. Trailbuilding in the area will help keep visitors to the area from disturbing the spring and retaining pond. The project at Manzano Lake will not effect a watershed, but within the westernmost section of the Estancia Basin, which is a endorheic basin that does not feed into any watershed. The Lake does supply the Manzano Spring and Ditch, a small acequia association that will benefit from the conservation of Manzano Lake's waters.

**No permitting is required due to both the nature of the projects and the fact that each land grant owns or has partnered with the co-owners at each respective project site.**

37. Is this project located in or near sensitive natural or cultural resource areas? Please explain and describe how this project will enhance or protect the surrounding area.

**The project on the Town of Tomé land grant will take place at the Tomé Hill Park, which skirts the bottom of El Cerro de Tomé (Tomé Hill), a regional shrine and pilgrimage destination which is recognized by the National Parks Service as site of multicultural spirituality. El Cerro de Tomé contains more than 1,800 petroglyphs from ancestral pueblos and the Spanish, Mexican and American (territorial and statehood) periods. Building, improving and maintaining trails and reducing erosion preserves these petroglyphs and also helps to preserve the post contact sacred landscapes that are a destination of spiritual practice throughout the region. The campground and trail project on the Cañón de Carnué Land Grant will build and/or improve trails along the riparian area of the Tijeras Creek, protecting the spring fed acequia and creek. The project at the San Antonio de las Huertas' Campo del Oso will build trails that will protect the springs and acequias that heirs have used since the communities founding in 1765, as well as storage ponds that help feed the acequias today.**

## **ECONOMIC IMPACT**

---

38. How will this project support and engage the local business community?

**Ancestral Lands Conservation Corps and the Taji que Land Grant, Chililí Land Grant, Manzano Land Grant, Town of Tomé Land Grant, Cañón de Carnué Land Grant and San Antonio de las Huertas Land Grant will attempt to purchase supplies from local and regional sellers, with special attention to small businesses, minority owned businesses and female owned businesses. Local businesses will benefit from increased visitation to each of the recreation sites, including Ray's Onestop, which is in Taji que and close to the Manzano and Torreón Land Grants, and the Old Mill Restaurant in Estancia. The Ten Points General Store is about a mile north of Chililí and is frequented by Merced de Chililí families. El Cerro Tomé on the Town of Tomé Land Grant is closed to dozens of businesses in the greater Tomé area (Tomé, Adelino, Los Chávez, Los Lunas, Belen, Valencia); the Rock Canyon Taproom, Burger Boy and other restaurants will benefit from the expansion of the Cañón de Carnué campground; the Merc, Placitas Pizza Co. and the Las Huertas Winery in Placitas (San Antonio de las Huertas).**

39. How many full, part-time, and/or seasonal jobs will this project create?

**One Crew Leader, one Assistant Crew Leader, and three corps members will be employed through this project, which will serve as a pilot to catalyze future Land Grant - Merced Conservation Corps opportunities based on the success of this project. We are leveraging funding through the New Mexico Land Grant Council and Taji que Land Grant Community to create a minimum of a 10-week paid service program for Land Grant-Merced youth. We will continue to pursue funding to extend the program for a longer period of time. Additionally, it is our goal to utilize this pilot project to catalyze more paid Youth Crew opportunities in additional Land Grant-Merced communities across the state, which will lead to the creation of many more jobs, up to 30 seasonal positions depending on the number of crews we are able to operate.**

40. What is the anticipated visitation impact of this project?

The Land Grant-Merced Regional Outdoor Recreation Project aims to improve accessibility to affordable and local outdoor recreation activities for the each community participating in the project. Improvements at each site will increase visitation by heirs, locals and visitors. Replacing the fill at the Torreón Community Center Playground will make the playground safer for youth and motivate families to use the park and playground more often. Building a trail away from the highway will improve the accessibility of the Chililí playground and give families the confidence that their children will be safe when traveling to and from the community center. Improving drainage will increase the safety of the Tajique park and playground, increasing visitation and use. The trail project at Manzano Lake will improve both the walking path and fishing access, which will increase visitation of the Lake. The campground project at Cañón de Carnué will expand opportunities by increasing the number of campsites available for use by heirs and other members of the community. The creation of trails at the San Antonio de las Huertas Land Grant's Campo del Oso will add yet another asset to the campground, increasing use by heirs and rentals by visitors. Finally, El Cerro Tomé is a regional pilgrimage site that sees visitation by the local population daily. Many visitors cannot make the trek up to the top of Tomé Hill and improvements to the trail at the Tomé Hill Park will provide for those local visitors, increasing the likelihood of more frequent use.

41. What are other specific economic impacts this project will have?

In addition to the jobs created by this project, program participants will receive professional development, training, and an AmeriCorps Education award, valued at \$1,678.57 to help pay for costs of college, university, and other accredited programs. One Crew Leader will earn \$685 - \$785/week, depending on experience, as well as fringe benefits. One Assistant Crew leader will earn \$600/week, as well as fringe benefits. Three Corpsmembers will earn \$400/week, as well as fringe benefits. Additionally, for the San Antonio de las Huertas Land Grant's Campo del Oso, the project work described above will lead to direct economic development through the creation and improvement of paid campsites. Campsites are currently able to be reserved and paid for through the Hip Camp website (<https://www.hipcamp.com/en-US/discover/new-mexico/el-campo-del-oso>), and improvements and creation of new sites will lead to additional revenue that the local community is able to realize, as well as additional revenue that is generated through increased visitation (fuel, food, other services).











The Tajique Land Grant is excited to submit this grant proposal for the Land Grant-Merced Outdoor Recreation Project, in partnership with the Chilili, Manzano, Town of Tomé, Torreón, Cañón de Carnué and San Antonio de las Huertas Land Grants as well as with the Ancestral Lands Conservation Corps, UNM Land Grant Studies Program, UNM School of Architecture and Planning and the New Mexico Land Grant Council. The Tajique Land Grant will serve as the lead applicant and fiscal agent for the grant. In addition, our land grant is committed to providing \$9,875.00 in matching funds. This will include 160 hours of time at a rate of \$16.97 per hour and 70 hours of time at a rate of \$25.87 per hour.

This project will provide financial assistance for projects in 7 land grant-merced communities. Each of these land grants-mercedes have very small annual operating budgets (less than \$10,000 per year) and therefore grant opportunities such as this provide them with the necessary resources to initiate projects to better serve their communities. While all these land grants-mercedes have existing community parks, playgrounds and open spaces, their lack of financial resources limits their ability to make needed improvement to increase access and use of these spaces. Therefore, the UNM Land Grant Studies Program encourages the Outdoor Recreation Division to fund this much needed project.

The New Mexico Land Grant Council, a state agency tasked with providing support to land grant-merced communities, writes this letter in support of the Land Grant-Merced Regional Outdoor Recreation Project. This year the Council has dedicated \$25,000 from its budget to support the establishment of a land grant-merced youth conservation crew. This \$25,000 will serve as a match for the Land Grant-Merced Regional Outdoor Recreation Project if funded. Jointly, the funding will leverage the ability to maintain at least a 10-week land grant-merced youth crew during the 2022 summer/fall work season. The ability to not only expand the amount of work time for the youth crew, but also to allow for the work to focus on these important outdoor recreation projects in our communities is of critical importance.

In addition, to providing \$25,000 towards the project, the Council will also provide at least \$2,800 in in-kind staff time toward the project. This will include at least 65 hours of time for the Council's program manager and at least 40 hours of time from a graduate planning student funded by the Council. The role of the Program Manager and the Student will be to help coordinate the project by serving as a liaison between the participating land grants and Ancestral Lands. Staff will also provide technical assistance to the Tajiique Land Grant as needed with the administration of the grant award and to the other land grants with planning and prepping for their portions of the project.

The Council strongly encourages the Outdoor Recreation Division to fund this collaborative project aimed at providing greater accessibility to outdoor recreation for the land grant-merced communities in Central New Mexico. It has the potential to serve seven rural, land grant-merced communities. These projects can greatly expand the access to and usage of the natural assets and outdoor community spaces, which the all of the participating land grants have already invested much time and labor into. We thank you, in advance, for giving the Land Grant-Merced Regional Outdoor Recreation Project consideration for funding in Fy 2022.
