## **Expansion of Services**

New Mexico Land Grant Council



#### Legal Services

- Currently provide legal services through contracts and partnerships
  - New Mexico Legal Aid Actively working on 3 litigations, 1 administrative adjudication, various other representations \$60,000.
  - UNM School of Law Clinical Law Program Natural Resources and Environmental Law Clinic – 1 active litigation - \$10,000.
  - UNM SOL Law Student Externships \$3,500.
  - New Mexico Department of Justice Treaty of Guadalupe Hidalgo Division Counsel to the Council, consultation and training on other land grant related matters.
  - Still under resourced in the area of legal representation for land grants.
  - Total Legal Services expenses in FY 2024 were \$73,500.
  - In FY 2025 total budgeted for Legal Services is \$70,500.
  - Would like to expand legal services provided to land grants by hiring full-time attorney on staff with either Council or Land Grant Merced Institute.



#### Land Surveying Services

- Currently provide surveyor services through contract
  - Last year provided surveying services to 5 land grants on 6 different projects
  - Total in surveying service costs in FY 2024 \$50,000.
  - Total budgeted for surveying services in FY 2025 \$40,000.
- Surveying services are also critical for preventing encroachments and for ligation involving boundary disputes.
- Ideally would like to have a surveyor on staff with the Council



### Natural Resources Management Support

- In FY 2024 provided support to two land grants with exploration of establishing mayordomo fuelwood project in Rio Arriba County via contract - \$10,000
- Funded YCC project for stream restoration in Torreón through contract with Ancestral Lands Indigenous and Land Grant Youth YCC - \$30,000
- Funded YCC project with East Rio Arriba Soil and Water Conservation District to develop natural resource plans for 4 land grants - \$30,000
- Provide direct staff support to fuelwood project with State Land Office in East Mountains serving Cañón de Carnué, Chililí, Torreón, Tajique and Manzano Land Grants; Villanueva serving San Miguel del Bado Land Grant.
- Would like to continue to invest in youth conservation projects and expand services by hiring a full-time natural resources planner to assist land grants with developing projects, applying for and administering funds.
- Total budgeted for Natural Resources Management in FY 2025 is \$10,000.



# Community and Economic Development Support

- In FY 2024 provided support to the Mercedes Unidas Center in Rio Arriba County through contract for planning assistance - \$10,000
- Would like to expand community and economic development services by hiring a full-time community and regional planner to assist land grants with developing projects, applying for and administering funds.
- Total budgeted for Community and Economic Development Support in FY 2025 is \$10,000.



#### Youth Development Programming

- In addition to YCC program work the Council has invested in youth development programming using of junior funds.
  - This included semester-long programs for High Students in Tierra Amarilla and Semester Long Program for middle school students in Taos.
- Land Grant Studies Program has also continued to support youth development through oral history projects involving youth, and curriculum development in partnership with NM Highlands.
- Would like to continue to invest in existing programs and have dedicated staff or contract services to help develop youth programs in land grant communities.



#### Research Services

- The need for continued research support is imperative for ligation.
- In FY 2023 we were able to digitize micro-film of about 3/4s of the Spanish and Mexican Archival materials owned by the Land Grant Studies Program.
- In FY 2023 and 2024 we were able to acquire materials from Malcolm Ebright from the Center for Land Grant Studies.
- Will digitize additional microfilm and make acquisitions from Center for Land Grant Studies in FY 2025.
- Need to organize archival materials we have on hand to make more readily available to public.
