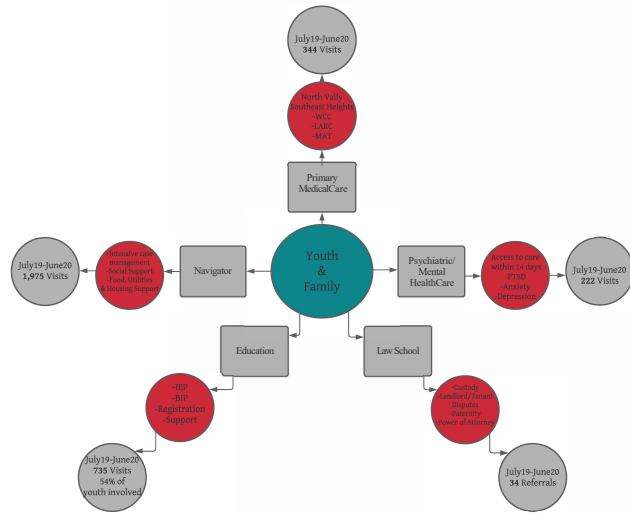
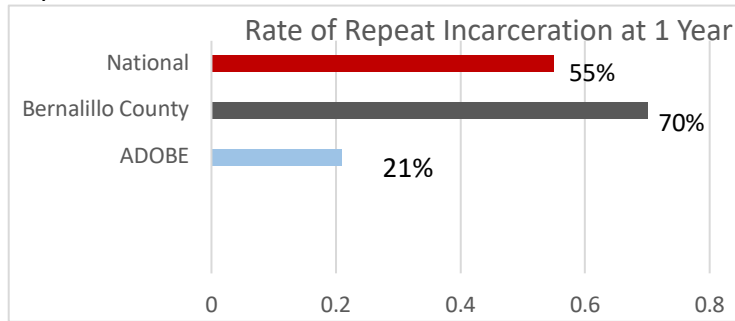


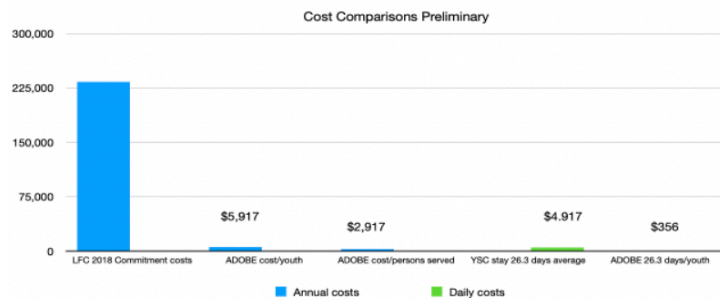

Process of ADOBE Services: Goal is continuity of engagement

Referrals: Bernalillo County Youth Services Center (YSC) Detention Center, CYFD Probation, Schools, Self

- Navigators met youth with Bernalillo County addresses at YSC, introduced program.
- At discharge, youth offered voluntary services in ADOBE and navigator home visits
- Post-pandemic, adjustments made to establish contact by virtual or phone meetings
- Navigators help with health harming social determinant needs; housing, food, utilities
  - Navigators organize health and psychiatric visits for youth and family members
  - Navigators have 20-25 primary youth on caseloads
  - Navigation extended for family members, children, significant others of youth
- Evaluate health harming legal needs; referred 34 to UNM Law Clinic for intake services
- Education liaisons share clients with navigators; connect youth to education services
  - Majority of youth leaving YSC have not attended school for 1-1 ½ years
  - Connect to APS regular and charter schools, PED charter schools, all kids in home
  - Post-pandemic; brought internet capable devices to family homes
  - Monitor progress, facilitate access to GED programs, attend school meetings
- Primary comprehensive medical home includes psychiatry and primary care
  - Navigators make appointments inside 14 days to psychiatric care
  - Full primary care for youth and family members including substance use medications

Evaluation Data; Life factors relate to two-generation two-brain care

Data sources from YSC, national data

- ADOBE serves family systems; enhanced high-fidelity wrap-around model
  - NM youth starting incarceration; 93.8% survived physical abuse, 87% have 4 or more ACEs, 36.5% have special education needs, and females have much higher rates.
  - 75% of youth in ADOBE have 4 or more ACEs
  - Families seen in ADOBE are surviving multiple adversities; access to care limited.
- Reduction in recidivism means fewer encounters with law enforcement, courts, and greater rates of clearing conditions of probation and parole.
- 50% of youth engage with education; during pandemic some entered honor roll

Implications for costs

- ADOBE costs are direct program costs, voluntary participation
- Incarceration in state system is all inclusive, county specific data may be different
- Added costs to system for court costs, prosecution and defense services, probation and parole
- ADOBE direct medical and psychiatric costs are paid from Medicaid, not included
- Return to YSC is 10 times more expensive over 26.3 days, more than 80% of ADOBE costs/year
- Access to behavioral health for youth and families is inconsistent; lack of coordinated care systems
- Outcomes measured include progress in education; benefits for every year completed, diploma, GED
- ADOBE can project scaling up to care for youth in greater Albuquerque Metro, possibly state
- ADOBE funding from Bernalillo County Behavioral Health Funds have ended effective June 30, 2021
