## Scientific Laboratory Division (SLD)

- Backlogs-Impaired Driving Alcohol testing backlog corrected as of the end of FY19.
- Backlog- drug facilitated sexual assault testing reduced
- 7 Vacancies in toxicology lab.
- Tested 1254 samples for school lead testing program.
- Completed appropriate salary placement for the scientific staff.



#### Division Of Health Improvement (DHI)

- Added 11 FTE: Incident Management Bureau (IMB), Quality Management Bureau (QMB) and (Jackson); Licensed only section (assisted living facility (ALF), boarding home (BH), crisis triage center (CTC), Home Health, Hospice) to address backlogs.
- Draft boarding home rules
- Placed surveyor/investigator job positions appropriately (impacted 80 staff who received a 10% salary increase, on average)



# Developmental Disabilities Supports Division (DDSD)

- Jackson Settlement Agreement implementation.
- 3 Phase plan to address wait list
- Concluding the Rate Study for the DD waiver.
- Transitioning the FIT and Families First programs to ECECD.

# Information Technology Services Division (ITSD)

- Collaboration with the state's Medicaid Management Information Systems replacement project (<u>HHS2020</u>).
- Implementation of a comprehensive <u>Electronic Healthcare</u> <u>Records</u> system, which will also create a mechanism to collaborate with other state agencies and local public health bodies to procure systems that are interoperable.



# Epidemiology & Response Division (ERD)

- Reduce deaths of despair [suicide, drug overdoses, alcohol-related death]
- Investigate and control outbreaks
- Develop climate adaptation plan
- Implement All Payer Claims Database (APCD)
- Move vital records into new building



# Medical Cannabis Program (MCP)

- 6 new qualifying conditions, including opioid use disorder.
- Implementing SB 406
- Increased plant count
- Addressing support needs in the MCP program secondary to program growth.



# Office of the Tribal Liaison (OTL)

- Compliance with the State Tribal Collaboration Act.
- Convening regional meetings to receive review and comment for the State Health Improvement Plan
- Collaborating with off-reservation population tribal serving organizations



# Office of Policy and Accountability (OPA)

- Legislative Requests, Jr. Bill appropriations, tracking implementation of NMDOH laws and rules
- Non-budget legislative proposals
- Performance measure negotiations with Legislative Finance Committee
- Health Equity




# Public Health Reaccreditation

- In November 2015, NMDOH was awarded public health accreditation by the Public Health Accreditation Board (PHAB)
- Reaccreditation due 2020.
- Best practice components NMDOH must demonstrate, include:
  - State Health Assessment
  - State Health Improvement
  - Strategic Planning
  - Performance Management
  - Quality Improvement

- Workforce Development
- Emergency Preparedness
- The reaccreditation expectations are broad reaching and inform and influence many of NMDOH's efforts for FY20 and beyond



#### Behavioral Health Collaborative-Effectively Address Substance Use Disorder

- Expand access to substance abuse treatment (including medication-assisted treatment (MAT)) service lines at Turquoise Lodge Hospital.
- Expand medical assisted treatment in primary care
- Mapping all existing treatment locations, including tribal locations-identifying gaps.
- Partnering with the Behavioral Health Services Division (BHSD) to evaluate existing programs.
- Seeking partnerships with Counties and UNM
- Identify strategies to address alcohol and meth




#### **Key Issues to Address**

- Safe site injection disease control
- Appropriate placement and retention of critical staff
- Green House Project

#### NMDOH Strategic Plan

- Increased NMDOH Accountability in Government Act (AGA) performance measures from 41 in FY20 to 73 in FY21's proposal
- Drafted NMDOH Interim FY20 Strategic Plan, which is focused on agency-wide goals, objectives and activities
- Scheduled a strategic planning retreat with NMDOH Senior Leadership for Sept. 6<sup>th</sup>, formulate the long-range Departmental goals



#### State Health Improvement Plan (SHIP)

- The NMDOH Strategic Plan has a different role and purpose than the State Health Improvement Plan (SHIP):
  - The NMDOH Strategic Plan establishes the Department's direction and plan of action, for things like making organizational practice improvements and assuring a competent public health workforce, whereas;
  - The State Health Improvement Plan determines and addresses the state's health priorities and how, in partnership with key partners, NMDOH can positively and collectively impact the significant health issues of the state.
