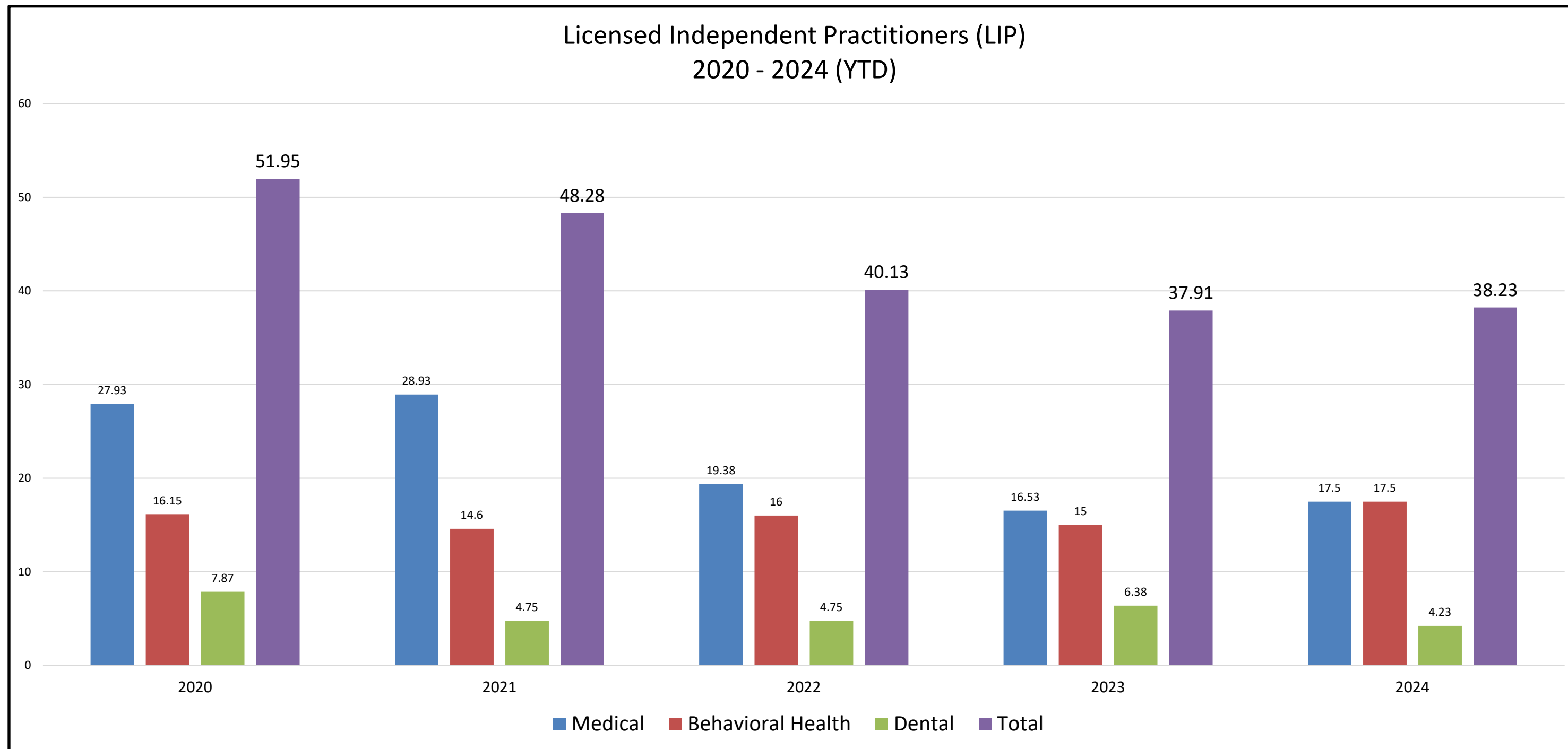


**Total Unduplicated Patients 14,026**



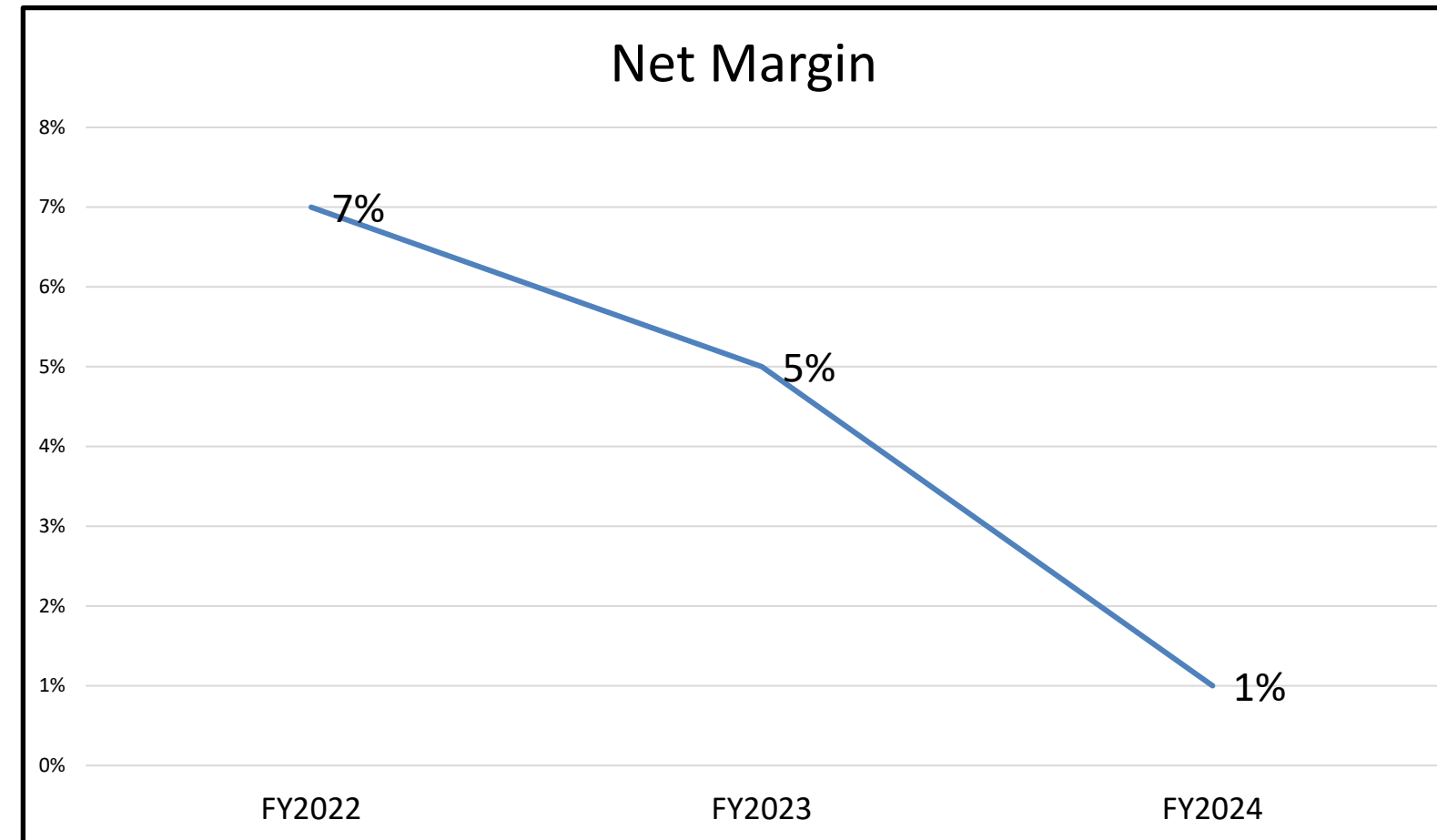

- Mental Health Therapists
  - Professional Counselor (LPCC, LMHC) - 5
  - Social Worker (LCSW, LMSW) - 6
- Substance misuse Counselors
  - Licensed Alcohol and Drug Abuse Counselor (LADAC) - 1
  - Licensed Substance Abuse Associate (LSAA) - 1
- Community Support Workers (CSW) - 5
- Certified Peer Support Workers (CPSW) - 3
- Care Coordinators – 2
- Medication Assisted Treatment (MAT) Coordinator - 1
- Psychiatric or Psycho-Social Rehabilitation (PSR) Coordinators - 2







# Behavioral Health Visits 2023

- Total mental health services provided 15,004
  - Unique patients 2,529
- Total substance misuse services provided 5,562
  - Unique patients 1,821
- Crisis intervention services provided – 462 (last 12 months)



# Visits by Diagnosis for 2023

- Alcohol-related disorders – 4,585
  - Unique patients – 531
- Other substance-related disorders (excluding tobacco) – 6,120
  - Unique patients – 739
- Depression and other mood disorders – 14,104
  - Unique patients – 2,123
- Anxiety disorders – 13,970
  - Unique patients – 2,440
- Attention deficit and disruptive behavior disorders – 1,765
  - Unique patients 400
- Other mental health disorders – 7,652
  - Unique patients – 1,567

# Crisis Intervention

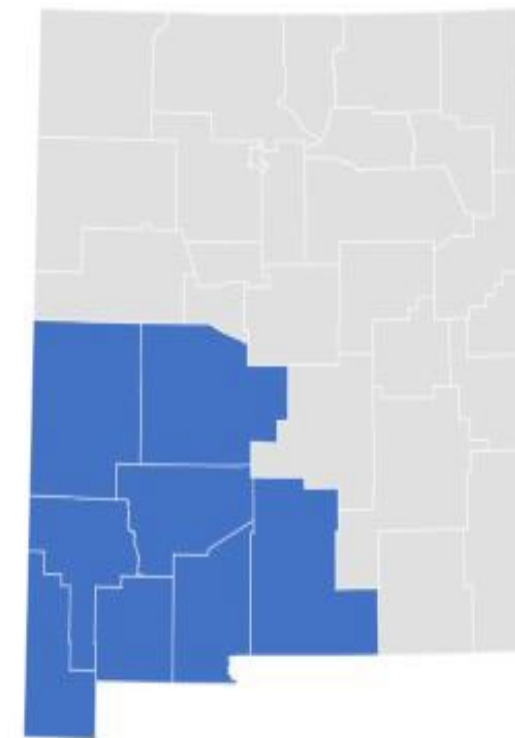
- Crisis walk-in appointments
  - In person
  - Telehealth
- Warm handoffs from primary care provider (PCP)/dental to behavioral health (BH) providers
- Most times, our BH providers help resolve the crisis
- Higher level of care
  - Emergency Department (local)
  - Acute inpatient treatment (not local)

  - Adults, Adolescents, and Children

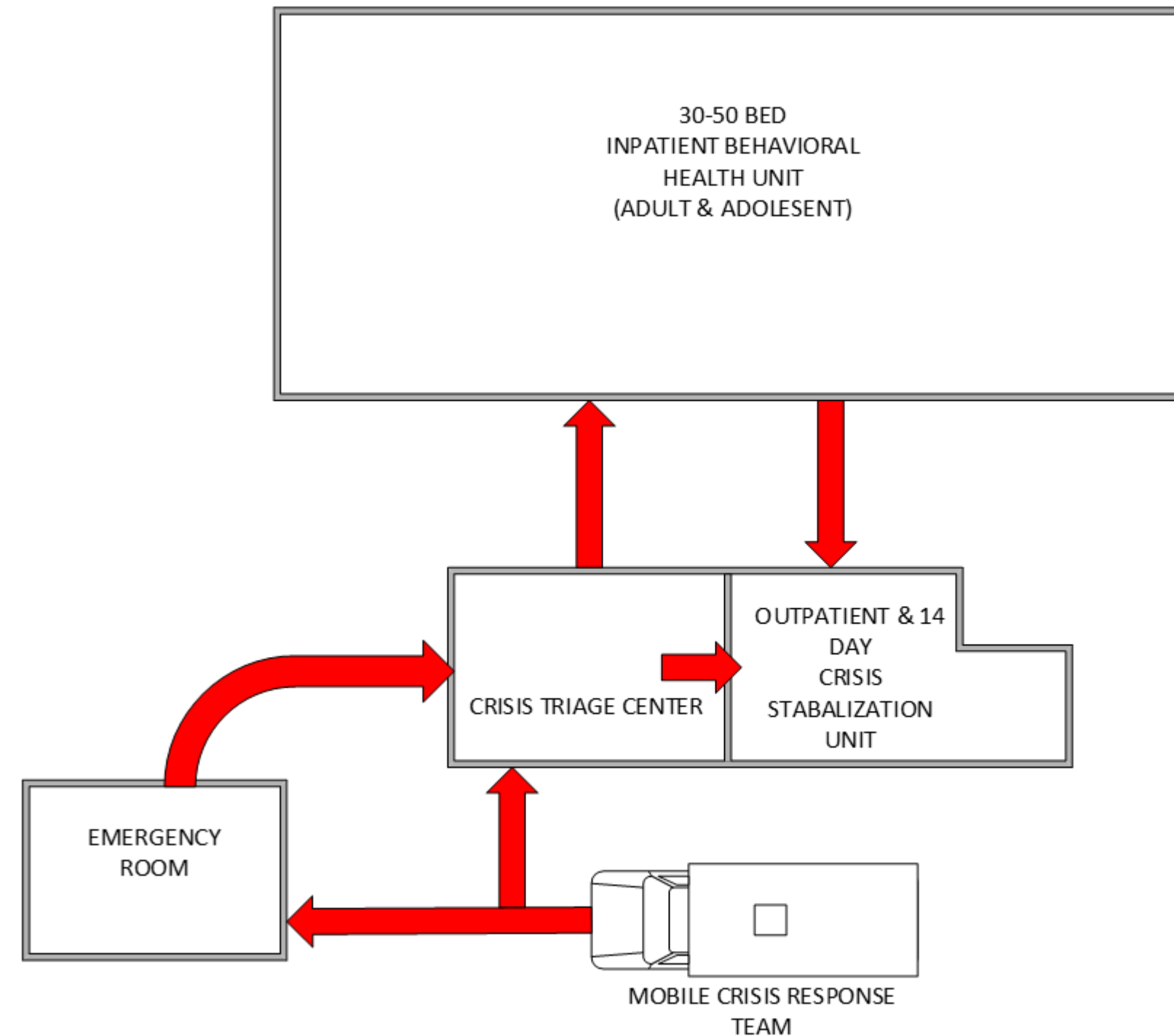

# Hidalgo Medical Services

## ➤ 2025 Legislative Session – HMS and Community Needs

1. Regional Behavioral Healthcare System funding
2. Funding to modernize 1960 primary care and behavioral health facility
3. State of the art security system (cameras and facility access)
4. Replacement of Hidalgo and Grant County X-Ray machines
5. Primary Care and Dental Mobile Units
6. Funding to Support Comprehensive Medical Transportation System
7. Increased Senior Center funding
8. Increased Medicaid rates to keep up with inflationary costs
9. Add needed funding to the Rural Primary Health Care Act
10. Statutory language to protect 340B program
