

Effects of Sweeps on PPRF

<u>One</u>

 Reduces the capacity of the NMFA to make loans to the entities that the PPRF serves:

Local Governments	Tribal Governments
State Agencies	Higher Education Institutions
Pubic School	Special Districts
Volunteer Fire Districts	

 For each dollar swept from the PPRF there is a corresponding one dollar reduction in loan capacity. For example, a \$10 million sweep from the PPRF flow through reduces the ability of the PPRF to provide \$10 million in loans to our clients.

Effects of Sweeps on PPRF

<u>Two</u>

- Reduces the ability of NMFA to payoff our bonds early.
- These early bond payoffs provide debt service savings which allows NMFA to provide additional funding to our clients.
- For example, a \$10 million sweep from the PPRF flow through prevents NMFA from paying our 2006C bonds off early and would have provided a \$5 million savings in debt service.
- This \$5 million dollars would allow NMFA to provide an additional \$5 million dollars in projects to our clients.
