# **PSCOC and PSFA Background**

- Current standards-based public school capital outlay program and the Public School Capital Outlay Fund (PSCOF) was developed and established in response to the 1998 Zuni lawsuit.
- New Mexico public school capital outlay process seeks to establish and implement a uniform funding system for capital improvements.
- Public school capital outlay funding is both a local and state responsibility in New Mexico.
- Public School Capital Outlay Council (PSCOC) manages the allocation of the Public School Capital Outlay Act Fund (PSCOF) to public school facilities statewide.
- PSFA is staff for PSCOC and carries out other functions to support school districts.

# **PSCOC Financial Plan Summary**

- The PSCOF has a dedicated funding stream from Supplemental Severance Tax Bonds (SSTBs).
- SSTBs are issued by New Mexico Board of Finance, paid for by revenue derived from taxes levied on natural resource products severed and saved from the soil.

# **Systems-Based (Small Projects) Awards**

- Program start date: 2017
- Systems-based awards are primarily for school facilities that don't need to be replaced nor to have major renovation
- Building systems are described as roofing, heating, cooling, windows, etc.
- Replacement of building systems are intended to extend the life of a school facility, reduce maintenance costs, and minimize operational costs

## Lease Assistance

- Program start date: 2005
- Lease assistance is based on student MEM or the classroom and administration net square footage (NSF) or lease costs, which ever is lower
- Assistance to charter schools or school districts may be up to \$747.29 per student MEM based on the certified 40 day count (this number is adjusted by the PSCOC annually)

## **Broadband Deficiencies Correction Program**

- Increase internet access and connectivity in public schools statewide.
- Provide fiber infrastructure to support scalable, fast and reliable internet to each school.
- In-the-building (internal) network equipment upgrades.
- Maximize the federal (E-rate) funding leveraged (~90 cents for every \$1 of upgrades).
- See the detail spreadsheet for a list of awarded broadband projects as well projects anticipating federal funding.
  - 146 Projects funded (2016-2019): 96 active/50 closed out
  - \$67M total work: \$59.1M E-rate
  - \$6M state
  - \$1.9M districts

# Facilities Master Plan (FMP) Awards (2005)

- Identifies the short and long term district vision.
- Road map that guides district decision making regarding facilities and systems.
  - What facilities only need general maintenance?
  - What facilities need renovation?
  - What facility or systems need to be replaced?
  - Does the district need a new facility or need to close a facility?
- Identifies options, strategies, and resources to address facility issues.
- Applications are being reviewed, awards scheduled to be made in November 2019.
- Current status:
  - 86 out of the 89 school districts have approved and/or are working on their FMP's
  - 11 districts are in the process of working on their new master plans

## **Pre-Kindergarten Classroom Facilities**

- Program start date: 2005
  - Public Education Department administered from 2006 to 2011 and 2014 to 2015.
  - PSFA administered in 2013 and 2018.
- Plan, design, renovation, and construction of public school pre-kindergarten classrooms statewide.
- Awards tentatively scheduled for second half of FY20.

# Teacher Housing & Outside of Adequacy Appropriations

- Legislative appropriation during 2019 Legislature (SB280) for school districts with federal impact aid for tribal lands
- \$10 million for teacher housing facilities (FY2019-2023)
  - PSCOF
  - Awards made to eligible school districts with existing teacher housing debt
- \$24 million for outside of adequacy (FY2019-2023)
  - General Fund
  - Program is following a streamlined application process and expedited timeline.
  - Awards scheduled to be made October 18, 2019.
  - Application project types include: Teacher housing (13), Athletics (10), HVAC (5), Infrastructure (5), Gym (4), Classrooms (3), Roof (2), Security (2), Other (2), Auditorium (1), Demolition (1).
