
## WHAT

## WHEN



 This vision came to life in early 2019 after completion of a USDA Feasibility Study grant, which looked at the potential of implementing makerspaces and/or business incubators in Grant County.

## WHERE



In collaboration with existing efforts to link Grant County communities via road, bike trails and walkways, the Five Points initiative will support & expand upon county-wide development in the outdoor recreation sector. Connections linked through biking, hiking and horse-riding trails offer extensive programming opportunities and health benefits. The proximity to Historic Fort Bayard will increase tourism activity and cultural programming prospects, as well as enhance connections to the Gila National Forest, Gila River, and Aldo Leopold Wilderness, for locals and tourists to further explore the innumerable natural assets of Southwest New Mexico.



#### IV. PATHWAY DESIGN STANDARD

The following Pathway Design Standards are proposed as guidelines for the planning, design and construction of the four pathway sections. Modifications to these standards are allowed when appropriate to specific circumstances that further achieve the goals of the pathway system.

#### 1. PRIMITIVE PATHWAY

These pathways are predominantly located within the creek bottoms; however, they may also be located wherever a narrow path is desired. They are built with greater sensitivity to the existing natural environment and are therefore narrower than the paths used in more developed parts of the system, but still should accommodate multiple user groups who prefer an unpaved surface. Primitive paths should be no wider than they need to be, with two to four feet being the recommended width range, and consisting of in-situ native soils on existing grade.

#### DESIGN CONSIDERATIONS

<u>Sight Lines</u>. Lay out paths to maximize visibility of approaching path users, thereby increasing reaction time and minimizing conflicts.

<u>Grades</u>. Lay out paths to minimize extreme slopes and grade changes thereby allowing users to stay under control at all times. A variety of slopes creates a more interesting and positive experience. <u>Plant Preservation</u>. Care should be given during path construction to preserve vegetation in place.





The Bradley Hotel: Site Map




The Bradley Hotel: The Vision




## The Union Hall Bayard

### FIVE POINTS - Phase Two and Beyond...

- The Waterworks site was chosen as Phase One, because it is the most shovel-ready project and because it is owned by the Town of Silver City and the Waterworks Building has been on the Town's ICIP list for years.
- The Whiskey Creek Zocalo and the Bradley Hotel are privately owned.
- The Steelworkers Union is in process of donating the Union Hall to the City of Bayard.
- The SW Railroad Depot is currently in negotiations with the Town of Hurley as to future "owners" of the Hurley Train Station.

### FIVE POINTS - Phase Two and Beyond...

- In January 2020, the Five Points Initiative was awarded the American Institute of Architects, Sustainable Design Assessment Team Award, \$15,000 in technical and design support
- Due to COVID travel restrictions, the AIA-SDAT team site visits were delayed until September and December 2021.
- Anticipated award completion date: Spring 2022
